At the annual general meeting of WH Group Limited (the “**Company**”) held on 9 May 2025 (the “**Annual General Meeting**”), a poll was demanded by the chairman of the Annual General Meeting for voting on all the proposed resolutions as set out in the notice (the “**Notice**”) of the Annual General Meeting of the Company dated 16 April 2025 (the “**Proposed Resolutions**”).

As more than 50% of the votes were cast in favor of the above resolutions numbered 1 to numbered 8, each of these resolutions was duly passed as an ordinary resolution of the Company.

As at the date of the Annual General Meeting, the total number of issued shares of the Company (the “**Shares**”) was 12,830,219,550, which was the total number of Shares entitling the holders to attend and vote for or against any of the Proposed Resolutions. There were no Shares entitling the holders to attend the Annual General Meeting and abstain from voting in favour of any of the Proposed Resolutions at the Annual General Meeting as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and there were no shareholders of the Company (the “**Shareholders**”) that were required under the Listing Rules to abstain from voting at the Annual General Meeting. No Shareholders have stated their intention in the circular of the Company dated 16 April 2025 to vote against or to abstain from voting on any of the Proposed Resolutions at the Annual General Meeting.

Computershare Hong Kong Investor Services Limited (“**Computershare**”), the branch share registrar of the Company in Hong Kong, was appointed as the scrutineers for the vote-taking at the Annual General Meeting.

Messrs. Wan Long, Guo Lijun and Lau, Jin Tin Don attended the Annual General Meeting in person.

PAYMENT OF FINAL DIVIDEND

In relation to the ordinary resolution No. 5 above, the final dividend of HK\$0.40 per Share for the year ended 31 December 2024 (the “**2024 Final Dividend**”) is expected to be paid in cash to the Shareholders on or about Thursday, 29 May 2025 whose names appear on the register of members of the Company on Tuesday, 20 May 2025.

For the purpose of ascertaining the Shareholders’ entitlement to the 2024 Final Dividend, the register of members of the Company will be closed from Friday, 16 May 2025 to Tuesday, 20 May 2025, both days inclusive. In order to qualify for the 2024 Final Dividend, all transfers of Shares accompanied by the relevant share certificates and appropriate transfer forms must be lodged for registration with Computershare at Shops 1712–1716, 17/F, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong, not later than 4:30 p.m. on Thursday, 15 May 2025.
