# VOLUNTARY ANNOUNCEMENT DEVELOPMENT COMMISSION SERVICE AGREEMENT AND STRATEGIC COOPERATION AGREEMENT TO DEVELOP AND OPERATE LOW-ALTITUDE AIRCRAFT RELATED BUSINESS

The Board is pleased to announce that on 7 July 2025, Minyi (an indirectly wholly-owned subsidiary of the Company) entered into the Development Commission Service Agreement with EHang, pursuant to which Minyi is engaged to design, develop, manufacture and install specified parts of low-altitude aircraft for EHang. On 21 July 2025, Minth Automotive Tech (an indirectly wholly-owned subsidiary of the Company) also entered into the Strategic Cooperation Agreement with EHang, pursuant to which the parties agreed to the framework of cooperation to jointly develop and operate low-altitude aircraft related business.

# THE DEVELOPMENT COMMISSION SERVICE AGREEMENT

Pursuant to the Development Commission Service Agreement, Minyi is engaged by EHang to design, develop, manufacture and install cabin door and other specified parts of multiple aircraft models, and such products shall be supplied by Minyi when these aircraft models commence commercial production.

### THE STRATEGIC COOPERATION AGREEMENT

The Strategic Cooperation Agreement sets out the objective, scope and certain guiding principles of the cooperation between Minth Automotive Tech and EHang to jointly develop and operate low-altitude aircraft related business for a term of five years.

Specifically, the principal areas and targets of the strategic cooperation include:

- (1) jointly develop airframe components for low-altitude aircraft;
- (2) jointly develop rotor system for low-altitude aircraft; and
- (3) jointly construct and develop transportation scenarios where low-altitude aircraft may be deployed and operated.

The Company will make further announcements as and when appropriate in accordance with the Listing Rules.

## INFORMATION ON THE PARTIES TO THE AGREEMENTS

EHang is a company incorporated in the PRC with limited liability and is an indirectly wholly-owned subsidiary of EHang Holdings Limited, which is listed on NASDAQ (stock code: EH). Together with its subsidiaries, EHang Holdings Limited is the leader in the global urban air mobility industry providing customers in various industries with low-altitude aerial vehicle systems and solutions. To the best of the knowledge, information and belief of the Company having made all reasonable enquiries, EHang and EHang Holdings Limited are independent third parties of the Company and its connected persons.

The Group is principally engaged in design, manufacturing, processing, development and sales of automobile body parts and moulds of passenger cars.

Minyi is a company incorporated in the PRC which is an indirectly wholly-owned subsidiary of the Company. Minyi is principally engaged in the design, production, and maintenance of civil aircraft and related components and its core operations also include the manufacture and sale of mechanical parts, high-performance fibers, and composite materials, as well as the research and development of new material technologies.

Minth Automotive Tech is a company incorporated in the PRC which is an indirectly wholly-owned subsidiary of the Company. Minth Automotive Tech is principally engaged in the research and development of automobile parts, the production of moulds and equipment as well as the manufacture and sale of mechanical parts.
