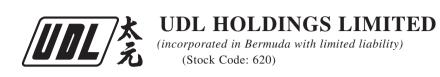

Reference is made to the (i) First Announcement dated 1 August 2008; (ii) the Second Announcement of the Company dated 21 August 2008; (iii) and the announcement of the Company dated 27 August 2008 in relation to the Expected Timetable and the closure of register of members and (iv) the Third Announcement.

EXPECTED TIMETABLE FOR THE RIGHTS ISSUE ("EXPECTED TIMETABLE")

Due to the delay in despatch of the Circular as stated in the Second Announcement and the further delay in despatch of the Circular as stated in the Third Announcement, the Expected Timetable has been revised. The Expected Timetable set out below is indicative only and it has been prepared on the assumption that (1) the Rights Issue will be approved by the Independent Shareholders at the SGM and (2) the Rights Issue Documents will be despatched to the Qualifying Shareholders on the Business Day immediately following the date on which the SGM is held. WARNING OF THE RISK OF DEALING IN THE SHARES AND NIL-PAID RIGHTS SHARES

The Shares will be dealt in on an ex-rights basis from 17 September 2008. Dealing in the Rights Shares in the nil-paid form will take place from 24 September 2008 to 2 October 2008 (both days inclusive). If the conditions of the Rights Issue are not fulfilled and/or waived, or the Underwriting Agreement is terminated by Taifook (on behalf of the Underwriters), the Rights Issue will not proceed and the Rights Issue will lapse.

Any persons contemplating buying or selling Shares from the date of this announcement up to the date on which all the conditions of the Rights Issue are fulfilled, and any dealings in the Rights Shares in their nil-paid form, bear the risk that the Rights Issue may not become unconditional or may not proceed.

The last day of dealings in Shares on a cum-rights basis is therefore expected to be Tuesday, 16 September 2008. The Shares are expected to be dealt with on an ex-rights basis from Wednesday, 17 September 2008.

CLOSURE OF REGISTER OF MEMBERS

No transfer of Shares will be registered during this period.
