

## (A) GRANTING OF GENERAL MANDATES TO REPURCHASE SHARES AND ISSUE SHARES

## (B) RE-ELECTION OF RETIRING DIRECTORS AND

#### NOTICE OF ANNUAL GENERAL MEETING

#### 1. INTRODUCTION

This circular contains an explanatory statement to be sent to the Shareholders in compliance with the Listing Rules to give all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the resolutions to approve the Repurchase Mandate, Share Issue Mandate and the re-election of retiring Directors. To the extent that the Directors are aware having made all reasonable enquiries, none of the Shareholders is required to abstain from voting on the resolutions.

## 2. PROPOSED GRANTING OF GENERAL MANDATES TO REPURCHASE AND ISSUE SHARES

At the annual general meeting of the Company held on 6 December 2013, the general mandates were granted to the Directors to repurchase and to issue Shares. Such mandates will lapse at the conclusion of the Annual General Meeting. In order to give the Company the flexibility to repurchase and to issue Shares if and when appropriate, the Ordinary Resolutions will be proposed at the Annual General Meeting to approve (i) the granting of the Repurchase Mandate to the Directors to repurchase Shares on the Stock Exchange of not exceeding 10% of the total nominal amount of share capital of the Company at the date of passing of the related Ordinary Resolution and (ii) the granting of the Share Issue Mandate to the Directors to allot, issue and deal with additional Shares of not exceeding 20% of the total nominal amount of share capital of the Company at the date of passing of the related Ordinary Resolution.

An Ordinary Resolution to extend the Share Issue Mandate by adding the number of Shares repurchased by the Company under the Repurchase Mandate will also be proposed at the Annual General Meeting.

With reference to the general mandate to repurchase and issue shares, the Directors wish to state that they have no immediate plan to repurchase any Shares or issue any new Shares pursuant to the Repurchase Mandate and the Share Issue Mandate.

An explanatory statement as required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the granting of the Repurchase Mandate is set out in Appendix I to this circular.

#### 3. PROPOSED RE-ELECTION OF RETIRING DIRECTORS

Pursuant to clause 99(A) as amended by clause 182(vi) of the Company's Bye-Laws and the code provisions in the Corporate Governance Code and Corporate Governance Report contained in Appendix 14 of the Listing Rules, Mrs. Leung Yu Oi Ling, Irene, Ms. Leung Chi Yin, Gillian and Professor Yuen Ming Fai, Matthew, *Ph.D.* will retire and, being eligible, offer themselves for re-election in the Annual General Meeting.

Professor Yuen Ming Fai, Matthew, *Ph.D.*, who has been serving as an Independent Non-executive Director of the Company for more than 9 years, has confirmed his independence with reference to the factors set out in Rule 3.13 of the Listing Rules. The Company considers Professor Yuen is still independent in accordance with the independence guidelines as set out in the Listing Rules and will continue to bring valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning.

Brief biographical and other details of the above retiring Directors are set out in Appendix II to this circular.

#### 4. ANNUAL GENERAL MEETING

The notice of the Annual General Meeting is set out on pages 12 to 14 of this circular. A proxy form for use at the Annual General Meeting is also enclosed therewith. Such form is also published on the websites of the Stock Exchange (www.hkexnews.hk) and of the Company (www.udl.com.hk) respectively.

The following Ordinary Resolutions, will be respectively proposed at the Annual General Meeting:

- to grant to the Directors a general mandate to exercise all powers of the Company to repurchase its Shares on the Stock Exchange representing up to 10% of the total number of issued shares in the share capital of the Company as at the date of passing of Ordinary Resolution No. 5:
- to grant to the Directors a general mandate to authorise the Directors to issue, allot and deal with Shares with an aggregate nominal value not exceeding 20% of the total number of issued shares in the share capital of the Company as at the date of passing of Ordinary Resolution No. 6; and
- to extend the general mandate which will be granted to the Directors to issue, allot and deal with additional Shares by adding to it the number of Shares repurchased under the Repurchase Mandate after the granting of the Share Issue Mandate.

#### 5. VOTING BY POLL AT GENERAL MEETING

Pursuant to the Listing Rules, any vote of Shareholders at a general meeting must be taken by poll except where the chairman decides to allow a resolution relating to a procedural or administrative matter to be voted on by a show of hands. Therefore, the resolutions put to vote at the Annual General Meeting will be taken by way of poll. An announcement on the poll vote results will be published by the Company after the Annual General Meeting on the websites of the Stock Exchange (www.hkexnews.hk) and of the Company (www.udl.com.hk) respectively.

#### 6. ACTION TO BE TAKEN

Whether or not you intend to attend the Annual General Meeting, you are requested to complete and sign the accompanying proxy form in accordance with the instructions printed thereon and return the same to the Company's branch share registrar in Hong Kong, Tricor Tengis Limited, at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for holding the Annual General Meeting or any adjournment thereof. Completion and return of the proxy form will not preclude you from attending and voting in person at the Annual General Meeting if you so wish.

#### 7. RESPONSIBILITY STATEMENT

This document, for which the Directors of the Company collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this document is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this document misleading.

#### 8. RECOMMENDATION

The Directors believe that the proposed re-election of retiring Directors and granting of the Repurchase Mandate and Share Issue Mandate are all in the best interests of the Company and its Shareholders. Accordingly, the Directors recommend all Shareholders to vote in favour of the related resolutions to be proposed at the Annual General Meeting. The Directors will exercise their voting rights in respect of all of their shareholdings (if any) in favour of the resolutions.

This appendix serves as an explanatory statement, as required by the Share Repurchase Rules, to provide requisite information reasonably necessary to you for your consideration to make an informed decision on whether to vote for or against the Ordinary Resolution to be proposed at the Annual General Meeting in relation to the granting of the Repurchase Mandate.

#### SHARE CAPITAL

As at the Latest Practicable Date, the number of Shares in issue was 275,115,408 of HK\$0.50 each. On the basis of such figure, assuming that no Shares would be issued or repurchased thereafter and prior to the Annual General Meeting, the Directors would be authorised to repurchase Shares up to a limit of 27,511,540 Shares (representing 10% of 275,115,408 issued share capital of the Company) under the Repurchase Mandate.

#### REASONS FOR SHARE REPURCHASE

The Directors have no present intention to make any repurchase of the Company's own Shares but consider that the mandate will provide the Company the flexibility to make such repurchases when appropriate and beneficial to the Company and its Shareholders. Such repurchases may enhance the net asset value of the Company and/or earnings per Share.

#### **FUNDING FOR REPURCHASES**

Repurchases must be funded out of funds legally available for the purpose in accordance with the laws of Bermuda, the Bye-Laws of the Company and/or any other applicable law, as the case may be. It is envisaged that the Company will derive the funds for repurchase of its shares in accordance therewith.

The Company is empowered by its Bye-Laws to repurchase its own Shares. The laws of Bermuda provide that the amount of capital repaid in connection with a share repurchase may only be paid out of either the capital paid up on the relevant shares, or out of the funds of the Company that would otherwise available for distribution by way of dividend or the proceeds of a new issue of shares made for such purpose. The amount of premium payable on the repurchases, if any, may only be paid out of either the funds of the Company that would otherwise be available for distribution by way of dividend or out of the share premium of the Company. Further, the Company may not purchase its own Shares if, on the date on which the purchase is to be effected, there are reasonable grounds for believing that the Company is or, after the purchase would be, unable to pay its liabilities as they become due.

#### IMPACT OF REPURCHASE

Based on the financial position of the Company as at 31 July 2014 (being the date of its latest published audited accounts), there could be a material adverse impact on the working capital and on the gearing position of the Company in the event that the proposed repurchases were to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to make any repurchases in the circumstances that would have a material adverse impact on the working capital or gearing position of the Company.

#### DIRECTORS, THEIR ASSOCIATES AND CONNECTED PERSONS

None of the Directors, to the best of the knowledge and belief of the Directors having made all reasonable enquiries, nor any of their Associates have any present intention, in the event that the proposed general mandates are approved by the Shareholders, to sell any Shares to the Company.

No connected person (as defined in the Listing Rules) of the Company has notified the Company that he/she has any present intention to sell any Shares to the Company nor he/she has undertaken not to sell any Shares held by him/her to the Company in the event that the Company is authorised to make repurchases of its own Shares.

#### UNDERTAKING OF THE DIRECTORS

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make repurchases of Shares pursuant to the proposed Repurchase Mandate in accordance with the Listing Rules, all applicable laws of Bermuda and the regulations and the Bye-Laws of the Company.

#### EFFECT OF TAKEOVERS CODE

If, on the exercise of the power to repurchase Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purpose of the Takeovers Code. Accordingly, a Shareholder or group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in the Shareholders' interest, could obtain or consolidate control of the Company and thereby become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best of the knowledge and belief of the Company, Mrs. Leung Yu Oi Ling, Irene ("Mrs. Leung"), the Chairman of the Company and her husband and children, and their Associates together were interested in approximately 72.31% of the issued share capital of the Company. In the event that the Directors would exercise the power in full to repurchase Shares which is proposed to be granted pursuant to the relevant Ordinary Resolution and if there is no other change in issued share capital of the Company, total interests of Mrs. Leung and her husband and children, and their Associates in the issued shares would be increased to approximately 80.34% of the total issued share capital of the Company. Save as aforesaid, the Directors are not aware of any consequences which would arise under the Takeovers Code as a consequence of any repurchase pursuant to the Repurchase Mandate. The Company is not aware of any Takeovers Code implication in respect of the Repurchase Mandate. The Directors will not exercise the Repurchase Mandate that will result in the number of Shares held by the public being reduced to less than 25%. The Directors do not have any present intention to exercise the proposed Repurchase Mandate to such an extent as would give rise to such a situation. Save as disclosed above, the Directors, to the best of their knowledge and belief, are not aware of any other substantial Shareholders holding 5% or more of the issued share capital of the Company as at the Latest Practicable Date.

#### REPURCHASES AND SHARE PRICES

During the six months preceding the Latest Practicable Date, the Company has not repurchased any of its Shares (whether on the Stock Exchange or otherwise).

## PARTICULARS OF RETIRING DIRECTORS PROPOSED FOR RE-ELECTION

The biographical and other details of the retiring Directors standing for re-election at the Annual General Meeting are set out below:

Mrs. Leung Yu Oi Ling, Irene, aged 61, joined the Group in June 1991 and is currently an Executive Director and the Chairman of the Company. She is a graduate of Leicester Polytechnic in UK and has had extensive experience in running her own interior design company prior to joining the Group. She is responsible for the general management, business development and marketing of the Group.

She is related to three Executive Directors of the Company, being the spouse of Mr. Leung Yat Tung, and the mother of Ms. Leung Chi Yin, Gillian and Mr. Leung Chi Hong, Jerry. She is connected to the substantial and controlling shareholders of the Company. She is one of the beneficiaries of the trust, in which the trustee of the trust is the substantial and controlling shareholder of the Company pursuant to Listing Rules 13.51(2)(e). As such, she was interested in 195,886,137 shares (representing approximately 71.20% of the issued share capital of the Company as at the Latest Practicable Date) of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

Save as the above, she did not hold any directorship in other listed public companies in the last three years. She is and was not connected with any other directors or senior management of the Company. She is connected to the substantial or controlling shareholders of the Company.

Mrs. Leung has a service contract with the Company for no specific term of appointment and is subject to retirement by rotation and be eligible for re-election at the Annual General Meeting in accordance with the provision of the Bye-Laws and the Corporate Governance Code and Corporate Governance Report; and receives salary of HK\$40,000 per month with Mandatory Provident Fund, staff quarter and performance bonus (if any), which was determined/reviewed by the Remuneration Committee and the Board based on authorisation to be granted by the Shareholders at the Annual General Meeting and with reference to her duties and responsibility with the Company, the Company's performance and current market condition. She is also entitled to participate in the share option schemes of the Group.

Save as the above, there is no other information relating to Mrs. Leung that is required to be disclosed pursuant to Listing Rules 13.51(2)(h) to 13.51(2)(v), and there are no other matters that need to be brought to the attention of the Shareholders of the Company.

Ms. Leung Chi Yin, Gillian, aged 34, was designated in September 2002 as an Executive Director. She graduated in Commerce from Queen's University, Canada and also completed MSc in Law and Accounting from the London School of Economics and Political Science, London. She is responsible for the financial management and administration of the Group.

She is related to three Executive Directors of the Company, being the daughter of Mr. Leung Yat Tung and Mrs. Leung and the sister of Mr. Leung Chi Hong, Jerry. She is connected to the substantial and controlling shareholders of the Company. She is one of the beneficiaries of the trust, in which the trustee of the trust is the substantial and controlling shareholder of the Company pursuant to Listing Rules 13.51(2)(e). As such, she was interested in 186,147,621 shares (representing approximately 67.66% of the issued share capital of the Company as at the Latest Practicable Date) of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

Save as the above, she did not hold any directorship in other listed public companies in the last three years. She is and was not connected with any other director or senior management of the Company. She is connected to the substantial or controlling shareholders of the Company.

## PARTICULARS OF RETIRING DIRECTORS PROPOSED FOR RE-ELECTION

She has a service contract with the Company for no specific term of appointment and is subject to retirement by rotation and be eligible for re-election at the Annual General Meeting in accordance with the provision of the Bye-Laws and the Corporate Governance Code and Corporate Governance Report; and receives salary of HK\$50,000 per month with Mandatory Provident Fund, which was determined/reviewed by the Remuneration Committee and the Board based on authorisation to be granted by the Shareholders at the Annual General Meeting and with reference to her duties and responsibility with the Company, the Company's performance and current market condition. She is also entitled to participate in the share option schemes of the Group.

Save as the above, there is no other information relating to Ms. Leung Chi Yin, Gillian that is required to be disclosed pursuant to Listing Rules 13.51(2)(h) to 13.51(2)(v), and there are no other matters that need to be brought to the attention of the Shareholders of the Company.

**Professor Yuen Ming Fai, Matthew,** *Ph.D.*, ("Prof. Yuen") aged 63, was appointed to the Board as the Independent Non-executive Director in April 2002. He spent 4 years in United Kingdom's industry before taking up a lecturing position at the University of Hong Kong in 1979. He is currently a Professor of the Department of Mechanical and Aerospace Engineering at The Hong Kong University of Science and Technology. He is a graduate of the University of Hong Kong and the University of Bristol. He is a Fellow of The Hong Kong Institution of Engineers and a Fellow of Institution of Mechanical Engineers, United Kingdom. He has extensive research experience in design and manufacturing. He is also appointed as an independent non-executive director of CHTC Fong's Industries Company Limited (stock code: 641). Save as the above, he did not hold any directorship in other listed public companies in the last three years.

Save as his spouse having personal interest in 96 shares (0.00%) of the Company, Prof. Yuen has no personal interest in the shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance. He does not has any relationship with any directors, senior management, the substantial or controlling shareholders of the Company pursuant to Listing Rules 13.51(2)(e).

Prof. Yuen receives a fee of HK\$10,000 per month, which was determined by the Remuneration Committee and the Board based on authorisation to be granted by the Shareholders at the Annual General Meeting and with reference to his duties and responsibility with the Company, the Company's performance and current market situation.

Prof. Yuen has entered into a services contract with the Company for a specific term, which is less than three years term and is subject to retirement by rotation and be eligible for re-election at the Annual General Meeting in accordance with the provision of the Bye-Laws and the Corporate Governance Code and Corporate Governance Report.

Save as the above, there is no information relating to Prof. Yuen that is required to be disclosed pursuant to Listing Rules 13.51(2)(h) to 13.51(2)(v) and there are no other matters that need to be brought to the attention of the shareholders of the Company.

Save as disclosed above, there are no other matters in respect of the re-election of these directors that need to be brought to the attention of the Shareholders of the Company.
