### NOTICE OF ANNUAL GENERAL MEETING

### INTRODUCTION

The purposes of this circular are to give you notice of the AGM, and information on the following proposals to be put forward at the AGM: (i) the grant to the Directors of the Issue Mandate; (ii) the Repurchase Mandate; (iii) the re-election of the retiring Directors; and (iv) the proposed amendments to the memorandum and articles of association and adoption of amended and restated memorandum and articles of association.

#### GENERAL MANDATES TO ISSUE NEW SHARES AND REPURCHASE SHARES

The Company's existing mandates to issue and repurchase Shares were approved by its then Shareholders on 30 December 2022. Unless otherwise renewed, the existing mandates to issue and repurchase Shares will lapse at the conclusion of the AGM.

Ordinary resolutions will be proposed at the AGM to grant to the Directors the following general mandates:

- (i) to allot, issue and otherwise deal with new Shares with an aggregate number of Shares not exceeding 20% of the number of Shares in issue as at the date of passing the proposed resolution at the AGM; and
- (ii) to repurchase Shares with an aggregate number of Shares not exceeding 10% of the number of Shares in issue as at the date of passing the proposed resolution at the AGM.

In addition, a separate ordinary resolution will be proposed at the AGM to add to the Issue Mandate those Shares repurchased by the Company pursuant to the Repurchase Mandate (if granted to the Directors at the AGM).

The Directors have no present intention to exercise the Issue Mandate or the Repurchase Mandate (if granted to the Directors at the AGM).

As at the Latest Practicable Date, a total of 3,405,582,652 Shares were in issue. Subject to the passing of the proposed resolution granting the Issue Mandate to the Directors and on the basis that no Shares will be issued and/or repurchased by the Company prior to the AGM, the Company would be allowed to issue a maximum of 681,116,530 Shares, representing 20% of the aggregate number of Shares in issue as at the date of the AGM.

An explanatory statement containing information regarding the Repurchase Mandate is set out in the Appendix I to this circular.

#### RETIREMENT OF DIRECTORS AND RE-ELECTION OF RETIRING DIRECTORS

The Board currently consists of six Directors, namely Mr. Wu Shaohao and Mr. Wu Liantao (*Chairman*) being the executive Directors; and Ms. Chung Wing Yee ("Ms. Chung"), Mr. Ma Yu-heng ("Mr. Ma"), Ms. Yang Xuping ("Ms. Yang") and Mr. Zhong Shuirong ("Mr. Zhong") being the independent non-executive Directors.

In accordance with Article 108(a) of the Articles, Mr. Wu Shaohao and Ms. Chung shall retire from office by rotation at the AGM and, being eligible, would offer themselves for re-election at the AGM.

In accordance with Article 112 of the Articles, Ms. Yang (who was appointed by the Board as an independent non-executive Director with effect from 6 March 2023), shall retire from office by rotation at the AGM and being eligible, would offer herself for re-election at the AGM.

Particulars of the Directors proposed to be re-elected at the AGM are set out in Appendix II to this circular.

### **Nomination Policy**

To promote Board diversity while maintaining the Board with appropriate balance of skills, continuity of experience and diversity of perspectives, the Nomination Committee will take into account a number of factors including but not limited to gender, background, qualifications, professional experience and skills to assess the suitability of proposed director candidates.

#### **Recommendations of the Nomination Committee**

The Nomination Committee has assessed the re-election of each of Mr. Wu Shaohao, Ms. Chung and Ms. Yang and has taken into account that:

- (i) Mr. Wu Shaohao's experience in overseeing the operations of the Group's businesses, his contribution to the Board and firm commitment to his role;
- (ii) Ms. Chung's experience in human capital management, her confirmation for independence pursuant to Rule 3.13 of the Listing Rules; and that she does not hold any cross directorships or have any significant links with other Directors through involvement in other companies or bodies; and
- (iii) Ms. Yang's expertise in Chinese law and regulatory compliance; her confirmation for independence pursuant to Rule 3.13 of the Listing Rules; and that she does not hold any cross directorships or have any significant links with other Directors through involvement in other companies or bodies.

In view of the above, the Board accepted the Nomination Committee's nomination and recommended Mr. Wu Shaohao, Ms. Chung and Ms. Yang to stand for re-election at the AGM. The Board considers that their re-election is in the best interest of the Company and the Shareholders as a whole.

# AMENDMENTS TO THE MEMORANDUM AND ARTICLES OF ASSOCIATION AND ADOPTION OF THE AMENDED AND RESTATED MEMORANDUM AND ARTICLES OF ASSOCIATION

On 1 January 2022, the Listing Rules were amended by, among others, adopting a uniform set of 14 core standards for shareholder protections for issuers regardless of their place of incorporation set out in Appendix 3 to the Listing Rules. The Board proposes to make certain amendments to the Memorandum and Articles of Association (i) to conform to the said core standards for shareholder protections; (ii) to provide flexibility to the Company in relation to the conduct of general meetings by allowing a general meeting to be held as an electronic meeting or a hybrid meeting; and (iii) to incorporate certain housekeeping changes and allow general meetings to be held as electronic meeting or a hybrid meeting. The Board also proposes to adopt the new Memorandum and Articles of Association in substitution for, and to the exclusion of, the existing Memorandum and Articles of Association.

Details of the amendments to the Memorandum and Articles of Association are set out in Appendix III to this circular. A special resolution will be proposed at the AGM to approve the proposed amendments to the Memorandum and Articles of Association.

The Company's legal advisers have confirmed that the proposed amendments conform with the requirements of the Listing Rules, where applicable, and the Cayman Islands laws. The Company also confirms that there is nothing unusual about the proposed amendments for a company listed in Hong Kong.

### RECOMMENDATION

The Directors consider that the grant of the Issue Mandate, the Repurchase Mandate, the reelection of the retiring Directors, and the amendments to the memorandum and articles of association of the Company are in the best interests of the Company and the Shareholders. Accordingly, the Directors recommend that all Shareholders vote in favour of the relevant resolutions as set out in the AGM Notice at the forthcoming AGM.

This appendix includes an explanatory statement required by the Stock Exchange to be presented to the Shareholders concerning the Repurchase Mandate proposed to be granted to the Directors.

#### 1. LISTING RULES FOR REPURCHASES OF SHARES

The Listing Rules permit companies with a primary listing on the Stock Exchange to repurchase their shares on the Stock Exchange subject to certain restrictions.

The Listing Rules provide that all proposed repurchases of shares by a company with a primary listing on the Stock Exchange must be approved by shareholders in advance by an ordinary resolution at a general meeting, either by way of a general mandate or by a specific approval of a particular transaction and that the shares to be repurchased must be fully paid up.

#### 2. FUNDING AND IMPACT OF REPURCHASES

Any repurchase will be made out of funds which are legally available for the purpose in accordance with the memorandum of association of the Company, the Articles, the Listing Rules and the applicable laws of the Cayman Islands. As compared with the financial position of the Company as at 30 June 2023 (being the date to which the latest audited accounts of the Company have been made up), the Directors consider that there would not be a material adverse impact on the working capital and on the gearing position of the Company in the event that the proposed repurchases were to be carried out in full during the proposed repurchase period.

The Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital of the Company or the gearing position which in the opinion of the Directors are from time to time appropriate for the Company.

#### 3. REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders to have a general authority from the Shareholders to enable the Directors to repurchase Shares on the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders.

### 4. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 3,405,582,652 Shares.

Subject to the passing of the relevant ordinary resolutions to approve the general mandates to issue and repurchase Shares and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the AGM, the Directors would be authorised to exercise the powers of the Company to repurchase a maximum of 681,116,530 Shares.

#### 5. UNDERTAKING OF THE DIRECTORS

The Directors have undertaken to the Stock Exchange to exercise the Repurchase Mandate in accordance with the Listing Rules, the applicable laws of the Cayman Islands and in accordance with the memorandum of association of the Company and the Articles.

#### 6. EFFECT OF THE TAKEOVERS CODE

If as a result of a repurchase of Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purpose of the Rule 32 of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert (within the meaning of the Takeovers Code), depending on the level of increase of the shareholding, but subject to the latitude provided by the 2% creeper provision under Rule 26 of the Takeovers Code could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date and insofar the Directors are aware of, Rui Er Holdings Company Limited ("Rui Er") is the legal and beneficial owner of 2,433,381,110 Shares (representing approximately 71.5% of the issued share capital of the Company), which was owned as to 100% by Mr. Wu Shaohao ("Mr. Wu"). In addition, as Ms. Yang Xijuan is the spouse of Mr. Wu, she was also deemed to be interested in the Shares held by Mr. Wu.

As a result, Rui Er and persons acting in concert with it (including Rui Er, Mr. Wu and Ms. Yang Xijuan) (the "Concert Group") were interested in more than 30% of the total number of issued Shares. In the event that the Repurchase Mandate was exercised in full, the shareholdings of the Concert Group would increase to approximately 79.4% of the issued share capital of the Company.

The Directors do not intend to exercise the power to repurchase Shares to an extent which would render any Shareholder or group of Shareholders obliged to make a mandatory offer under Rule 26 of the Takeovers Code. The Directors have no intention to exercise the Repurchase Mandate to such an extent that result in a public shareholding of less than the minimum public float requirement of 25% of the total issued share capital of the Company.

### 7. DIRECTORS, THEIR ASSOCIATES AND CONNECTED PERSONS

None of the Directors nor, to the best knowledge and belief of the Directors, having made all reasonable enquiries, any of their respective close associates has any present intention, in the event that the proposed Repurchase Mandate is granted, to sell Shares to the Company. No core connected person of the Company has notified the Company that he/she/it has any present intention to sell Shares to the Company, nor has he/she/it undertaken not to sell any of the Shares held by him/her/it to the Company, in the event that the Company is authorised to make repurchases of Shares.

### 8. SHARE REPURCHASE MADE BY THE COMPANY

No repurchase of Shares has been made by the Company (whether on the Stock Exchange or otherwise) during the six months ended on the Latest Practicable Date.

#### Mr. Wu Shaohao

Mr. Wu Shaohao (吳紹豪先生), aged 56, has over 20 years of management experience in property development in the PRC and was appointed as the executive director of the Company since 4 December 2018. Mr. Wu obtained a master of educational leadership degree from the University of Canberra. He has been the chairman of the board of directors of 江蘇瑞爾房地產集團公司 (Jiangsu Ruier Property Development Group Company Limited\*) ("Jiangsu Ruier"), 上海電子商城有限公 司 (Shanghai E-commerce Company Limited\*) ("Shanghai E-commerce"), 瀋陽金沙城置業有限公 司 (Shenyang Sands City Property Company Limited\*) ("Shenyang Sands") and 江蘇水之源置業有 限公司 (Jiangsu Shuizhiyan Property Company Limited\*) ("Jiangsu Shuizhiyan") since March 2000. Jiangsu Ruier, Shenyang Sands and Jiangsu Shuizhiyan are principally engaged in property development business and Shanghai E-commerce is principally engaged in operating a wholesale market in Jiading, Shanghai. Mr. Wu Shaohao is the father of Mr. Wu Liantao, an executive Director.

Mr. Wu Shaohao is the director of Rui Er Summi (BVI) Limited (瑞爾森美 (英屬維爾京群島) 有限公司), Rich Anges Limited (裕佳有限公司), Global One Management Limited, Summi Yummv Limited (森美波仔有限公司), Sunshine Vocal Limited and Potel Limited (邦天有限公司), which are wholly owned subsidiaries of the Company.

Mr. Wu Shaohao is also the shareholder of Rui Er Holdings Company Limited (瑞爾控股有限 公司), which are company having an interest in the shares of the Company. As at the Latest Practicable Date, Mr. Wu Shaohao was the legal and beneficial owner 2,433,381,110 Shares, representing approximately 71.5% of the issued share capital of the Company.

Mr. Wu Shaohao has entered into a director's service agreement with the Company on 4 December 2018, which may be terminated by either party giving to the other party not less than one months' prior written notice and is not entitled to receive a basic annual salary which was determined with reference to the prevailing market practice, the Company's remuneration policy, his duties and responsibilities with the Group. He is entitled to receive a discretionary bonus and subsidies subject to the approval by the Board. Mr. Wu Shaohao is subject to re-election or retirement by rotation at the general meetings of the Company pursuant to the Articles.

Save as disclosed above, as at the Latest Practicable Date, Mr. Wu Shaohao (a) does not hold any other position with the Group; (b) did not hold any directorship in any listed public companies in Hong Kong or overseas in the last three years; (c) does not have any relationship with any Directors, senior management or substantial or controlling shareholders of the Company; (d) does not have any interest in any shares, underlying shares or debentures of the Company within the meaning of Part XV of the SFO; and (e) there is no other matter concerning Mr. Wu Shaohao that needs to be brought to the attention of the Shareholders nor any information to be disclosed pursuant to the requirements of Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

### Ms. Chung Wing Yee

Ms. Chung Wing Yee (鍾穎恰女士) ("**Ms. Chung**"), aged 41, has been appointed as an independent non-executive Director with effect from 11 July 2022. She has over 10 years of experience in human capital management and office administration. She is currently the human resources and general manager of a professional service firm, which provides professional services in the fields of accounting, taxation, other business management and company secretary. Ms. Chung obtained a Bachelor of Arts degree in international business management from University of Northumbria in 2009.

Ms. Chung has entered into a letter of appointment for an initial term of two years commencing from 11 July 2022. She is entitled to receive director's fee of HK\$150,000 per annum, which has been determined by the Board with reference to her experience, duties and responsibilities undertaken with the Company and prevailing market conditions. Ms. Chung is subject to re-election or retirement by rotation at the general meetings of the Company pursuant to the Articles.

Save as disclosed above, as at the Latest Practicable Date, Ms. Chung (a) does not hold any position with the Group; (b) did not hold any directorship in any listed public companies in Hong Kong or overseas in the last three years; (c) does not have any relationship with any Directors, senior management or substantial or controlling shareholders of the Company; (d) does not have any interest in any shares, underlying shares or debentures of the Company within the meaning of Part XV of the SFO; and (e) there is no other matter concerning Ms. Chung that needs to be brought to the attention of the Shareholders nor any information to be disclosed pursuant to the requirements of Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

#### Ms. Yang Xuping

Ms. Yang has entered into a letter of appointment for an initial term of two years commencing from 6 March 2023. She is entitled to receive director's fee of RMB120,000 per annum, which has been determined by the Board with reference to her experience, duties and responsibilities undertaken with the Company and prevailing market conditions. Ms. Yang is subject to re-election or retirement by rotation at the general meetings of the Company pursuant to the Articles.
