VOLUNTARY ANNOUNCEMENT INCREASE IN SHAREHOLDING BY THE CHAIRMAN AND AN EXECUTIVE DIRECTOR

The announcement is a voluntary disclosure made by Solargiga Energy Holdings Limited (the “**Company**”).

The board of directors of the Company (the “**Board**”) was informed that Mr. Tan Wenhua (“**Mr. Tan**”), the chairman and an executive director of the Company, during the past five business days, acquired on the market an aggregate of 9,570,000 shares of the Company with an average price of approximately HK\$0.170 per share, representing 0.30% of the entire issued share capital of the Company as at the date of this announcement, at a total consideration of approximately HK\$1,629,000. Immediately after the aforesaid acquisitions, Mr. Tan’s shareholding in the Company increased from approximately 21.30% to approximately 21.60%.

Mr. Tan has expressed to the board of directors of the Company that he has confidence in the prospects of the Group. Mr. Tan has further expressed his intention to continue to acquire shares of the Company in the future in appropriate circumstances.
