If your email address provided is non-functional, until such time that a functional email address is received by the Company's Share Registrar, Hong Kong Registrars Limited, you may (i) be unable to receive any notifications regarding the publication of Corporate Company's website at www.chinaunicom.com.hk and the HKEx's website at www.chinaunicom.com.hk and the HKEx's website at www.hkexnews.hk to keep up with the publication of Corporate Communication.

If the Company does not receive the duly completed and signed Reply Form or any responses from you indicating your objection to receive the Electronic Version through the Company's website by 11 October 2024, you are deemed to have elected the Electronic Version instead of the Printed Version. If you have elected (or are deemed to have elected) the Electronic Version but for any reason have difficulty in accessing the relevant Corporate Communication electronically, or wish to receive Printed Version, the Company will promptly upon receiving your request send the Printed Version to you free of charge. Your request for the Printed Version will remain valid until the instruction has been revoked, superseded, or expired, or for one year from the date of receiving your instruction (whichever is earlier).
