In June 2010 and October 2011, the Company granted 112,175,000 (of exercise price HK\$ 0.65 per share) and 23,600,000 share options (of exercise price HK\$ 0.52 per share) to various Eligible Participants respectively. As of 29 February 2012, 61,903,500 and 23,600,000 share options from the respective grant were outstanding (not yet cancelled or lapsed). The figures disclosed in the above sections refer to those which were vested as at 29 February 2012. On 2 March 2012, the composite document relating to the mandatory unconditional cash offer of shares of the Company was issued and all the share options then outstanding became exercisable (and would lapse upon closing of the offer).
