**QUARTERLY UPDATE – OPERATING INFORMATION FOR
THE THREE MONTHS ENDED 31 MARCH 2014**

The Group recorded a new contract value of HK\$684 million in the three months ended 31 March 2014, representing a growth of 54.4% as compared with the same period last year, and hence achieved a 34.2% completion of the full year target of 2014 (which is not less than HK\$2,000 million).

As of 31 March 2014, the on-hand contract value amounted to approximately HK\$3,644 million, among which the backlog was approximately HK\$2,704 million (representing an increase of 55.2% as compared to the backlog as of 31 March 2013), which meets the Group's expected future works.

Major New Contracts Awarded in 1Q 2014:

MGM Cotai Project in Macau (the attributable contract value of the Group is about HK\$544 million);

Vancouver Stock Exchange in Vancouver, Canada (the attributable contract value of the Group is about HK\$94 million).
