**ANNOUNCEMENT PURSUANT TO RULE 13.09(2) OF THE LISTING RULES
AND THE INSIDE INFORMATION PROVISIONS**

This announcement is made by Far East Global Group Limited (the “Company”) pursuant to Inside Information Provisions (as defined under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”)) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong) (the “SFO”) and Rule 13.09(2) of the Listing Rules.

The Company is an indirect subsidiary of China State Construction International Holdings Limited (“CSCIHL”, whose shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited). As at the date of this announcement, CSCIHL beneficially owns approximately 74.06% of the issued share capital of the Company.

CSCIHL will, on or about 19 October 2015, announce its unaudited third quarter results of 2015 pursuant to the disclosure obligation under Rule 13.09(2) of the Listing Rules and Inside Information Provisions under Part XIVA of the SFO. Such results will contain the financial information of the Company and its subsidiaries (collectively, the “Group”) which is consolidated in the accounts of CSCIHL.

To ensure that shareholders of the Company and potential investors have equal and timely access to the information pertaining to the Company, the Board of Directors of the Company is pleased to present the following operating results of the Group for the nine months ended 30 September 2015.

For the nine months ended 30 September 2015, the unaudited revenue of the Group was about HK\$1,383,157,000 (30 September 2014: HK\$1,147,669,000). Some of the new projects in Hong Kong are still at their early preparatory stage, revenue contribution of such projects will increase gradually. The operating profit was about HK\$65,555,000 (30 September 2014: HK\$25,813,000).

Shareholders of the Company and potential investors should note that **all financial information contained in this announcement is unaudited. Accordingly, such information shall in no way be regarded as to provide any indication of or assurance on the financial results of the Group for the nine months ended 30 September 2015.**
