**QUARTERLY UPDATE – OPERATING INFORMATION FOR  
THE THREE MONTHS ENDED 31 MARCH 2017**

The Group recorded a new contract value of HK\$868 million in the three months ended 31 March 2017, representing a growth of 13.2% as compared with the same period last year, and hence achieved a 24.8% completion of the full year target of 2017 (which is not less than HK\$3,500 million).

As of 31 March 2017, the on-hand contract value amounted to approximately HK\$8,042 million, among which the backlog was approximately HK\$4,522 million (representing an increase of 20.7% as compared to the backlog as of 31 March 2016), which meets the Group's expected future works.
