PROPOSALS FOR (1) RE-ELECTION OF DIRECTORS; (2) GENERAL MANDATES TO ISSUE SHARES AND BUY BACK SHARES; AND (3) AMENDMENTS TO THE ARTICLES OF ASSOCIATION AND NOTICE OF THE ANNUAL GENERAL MEETING

INTRODUCTION

The Company will propose at the AGM resolutions to, *inter alia*, (i) re-elect the Directors; (ii) grant to the Directors the Issue Mandate and the Buy-back Mandate upon the expiry of the current general mandates to issue Shares and buy back Shares granted to the Directors at the annual general meeting of the Company held on 8 June 2022; and (iii) amend the Articles of Association.

The purpose of this circular is to provide you with further information on resolutions to be proposed at the AGM and to give you notice of the AGM.

RE-ELECTION OF DIRECTORS

In accordance with article 84(1) of the Articles of Association, Mr. Zhang Haipeng and Mr. Wu Mingqing will retire by rotation at the AGM and, being eligible, offer themselves for re-election.

In accordance with article 83(3) of the Articles of Association, Mr. Wong Man Cheung, Ms. Chan Man Ki Maggie and Mr. Zhang Xinyu who were appointed by the Board, will hold office until the AGM and, being eligible, offer themselves for re-election.

The Nomination Committee reviews the composition of the Board annually to ensure that it reflects an appropriate mix of skills, experience, and diversity that are relevant to the Group's businesses and contribute to the Board's effectiveness and efficiency.

Recommendations to the Board for the proposal in relation to re-election of Directors were made by the Nomination Committee after considering the composition of the Board and a range of diversity perspectives including but not limited to gender, age, educational background, professional experience, knowledge and other qualities as set out in the Board diversity policy.

As regards the two Independent Non-executive Directors proposed to be re-elected at the AGM, Ms. Chan Man Ki Maggie is a seasoned solicitor with vast experience in legal and regulatory matters and is the only female member on the board whereas Mr. Zhang Xinyu possesses expertise in civil engineering with solid experience in the logistics and transport industry. The Nomination Committee and the Board believe that the expertise and experience brought by them are valuable complements to the Board. Each of Ms. Chan and Mr. Zhang had confirmed her/his independence pursuant to Rule 3.13 of the Listing Rules. During their tenure of office, they have not been involved in the day-to-day management of the Company nor in any relationships or circumstances which would interfere with their exercise of independent judgement.

The nomination of both Ms. Chan and Mr. Zhang was made in accordance with the nomination policy and took into account the above factors, the composition of the Board and the diversity aspects as set out in the Board diversity policy. The Board, having considered the recommendation of the Nomination Committee, is of the view that both Ms. Chan and Mr. Zhang have the required character, integrity, independence and expertise to fulfil their role as Independent Non-executive Directors and should be re-elected.

The biographical details of the Directors who are proposed to be re-elected at the AGM are set out in Appendix I to this circular.

ISSUE MANDATE AND BUY-BACK MANDATE

At the annual general meeting held on 8 June 2022, ordinary resolutions were passed by Shareholders granting to the Directors (i) a general mandate to allot, issue and dispose of additional Shares up to a limit equal to 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing such resolution; and (ii) a general mandate to exercise the powers of the Company to buy back the Shares up to a limit of 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing such resolution. A further ordinary resolution was passed by Shareholders granting to the Directors a general mandate to allot, issue and dispose of the Shares bought back by the Company pursuant to the general mandate to buy back Shares.

These general mandates will expire at the conclusion of the AGM. Resolutions will be proposed seeking Shareholders' approval for, *inter alia*, the renewal of a general mandate enabling the Directors to allot, issue and dispose of additional Shares; the renewal of a general mandate to buy back Shares and the renewal of a general mandate enabling the Directors to allot, issue and dispose of the Shares bought back by the Company pursuant to the Buy-back Mandate during the period from the passing of the relevant resolutions at the AGM until the earliest of (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any applicable laws to be held; and (iii) the date on which the authority set out in the relevant resolution is revoked or varied by an ordinary resolution of the Shareholders in general meeting.

An explanatory statement as required by the Listing Rules in connection with the Buy-back Mandate is set out in Appendix II to this circular.

AMENDMENTS TO THE ARTICLES OF ASSOCIATION

On 1 January 2022, the Listing Rules were amended by, among others, adopting a uniform set of core shareholder protection standards ("Core Standards") as set out in Appendix 3 to the Listing Rules for issuers regardless of their place of incorporation. In this connection, the Board proposes that certain amendments to the existing Articles of Association be made to (i) bring the Articles of Association in conformity with the Core Standards, (ii) provide flexibility to the Company to hold general meetings as hybrid meetings or electronic meetings where the Shareholders may attend by means of electronic facilities in addition to physical attendance, (iii) bring the Articles of Association in line with other requirements of the Listing Rules and applicable laws of the Cayman Islands, and (iv) incorporate certain consequential and minor house-keeping amendments.

The Board proposes to put forward to the Shareholders for approval at the AGM a special resolution to amend the Articles of Association and to adopt the Amended and Restated Articles of Association in the form to be tabled at the AGM in substitution for, and to the exclusion of, the Articles of Association.

The proposed amendments are set out in Appendix III to this circular.

ANNUAL GENERAL MEETING

The notice convening the AGM is set out on pages 72 to 75 of this circular.

The register of members of the Company will be closed from Thursday, 1 June 2023 to Tuesday, 6 June 2023 (both days inclusive) for the purpose of determining Shareholders' entitlement to attend and vote at the AGM. Mr. Zhang Haipeng – Chairman and Non-executive Director

Aged 47, has been Chairman of the Board and Non-executive Director since August 2018. Mr. Zhang is also the Chairman of the Nomination Committee of the Company and a member of the Remuneration Committee of the Company. He graduated from Harbin Institute of Technology, and obtained a degree of Master of Business Administration from Hong Kong Baptist University and a degree of Executive Master of Business Administration from Nankai University. Mr. Zhang was awarded the title of Senior Engineer. He joined CSCEC in 2000 and was seconded to the CSC Group in 2002. Mr. Zhang has been a director of certain subsidiaries of CSC since 2008. Ms. Chan Man Ki Maggie – Independent Non-executive Director

Aged 54, has been an Independent Non-executive Director since July 2022. Ms. Chan is also a member of the Audit Committee, Nomination Committee, Remuneration Committee and Sustainability Committee of the Company. She obtained her Bachelor degree in Laws and Postgraduate Certificate in Laws from the University of Hong Kong in 1991 and 1992 respectively. Ms. Chan is the founder and managing partner of CMK lawyers, a law firm in Hong Kong, and has over 28 years of experience in providing legal advices and services as a solicitor in Hong Kong. She is also a lawyer in the Guangdong-Hong Kong-Macao Greater Bay Area and her practicing institution is Sino-Win Law Firm.

Ms. Chan is an Accredited Mediator and a China-Appointed Attesting Officer in Hong Kong. She is also the founding president of The Small and Medium Law Firms Association of Hong Kong. Furthermore, Ms. Chan is a Specially Invited Mediator of Guangdong Court for Cross-border Commercial Dispute Resolution in the Guangdong-Hong Kong-Macao Greater Bay Area, a Mediator of Shenzhen Qianhai International Commercial Mediation Centre, and an Arbitrator of China Guangzhou Arbitration Commission, Shenzhen Court of International Arbitration and Qingdao Arbitration Commission. She is currently an independent non-executive director of Wine's Link International Holdings Limited, Beijing Enterprises Holdings Limited and Nine Dragons Paper (Holdings) Limited. The aforesaid companies are all listed in Hong Kong.

PARTICULARS OF DIRECTORS

Ms. Chan has also undertaken various community positions in Hong Kong including being an Ex-officio Member of Election Committee and Chairman of Appeal Tribunal Panel (Building Ordinance). She was awarded the Medal of Honor in 2012 and Justice of the Peace in 2015 by the Government of the Hong Kong Special Administrative Region. Ms. Chan was also conferred with Honorary Fellow by City University of Hong Kong in 2013. Ms. Chan currently receives a director's emolument of HK\$250,000 per annum which was determined by reference to her duties and responsibilities with the Company, the Company's standard for emoluments and the prevailing market conditions.

Mr. Zhang Xinyu – Independent Non-executive Director

Aged 34, has been an Independent Non-executive Director since July 2022. Mr. Zhang is also a member of the Audit Committee, Nomination Committee, Remuneration Committee and Sustainability Committee of the Company. He graduated from the University of Hong Kong with a Bachelor of Engineering Degree in Civil Engineering. Mr. Zhang is a Member of The Hong Kong Institution of Engineers ("HKIE") and Co-opted Member of The HKIE Council and a Chartered Engineer of the Institution of Civil Engineers. He is also a Chartered Member of The Chartered Institute of Logistics and Transport. Mr. Zhang worked for MTR Corporation Limited and was responsible for the construction of various new railway projects and train operations. He is a Legislative Council Member of the Hong Kong Special Administrative Region elected in 2022. Mr. Zhang has over 12 years of experience in engineering field.

APPENDIX II EXPLANATORY STATEMENT FOR THE BUY-BACK MANDATE

This Appendix II serves as an explanatory statement, as required by the Listing Rules, to provide the requisite information to the Shareholders for consideration of the Buy-back Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 2,255,545,000 Shares.

Subject to the passing of Resolution (7) as set out in the Notice of the AGM and on the basis that no further Shares are issued or bought back prior to the AGM, the Company would be allowed under the Buy-back Mandate to buy back a maximum of 225,554,500 Shares, which represents 10% of the shares of the Company in issue at the date of passing the resolution.

2. REASONS FOR THE BUY-BACKS

The Directors believe that it is in the best interests of the Company and the Shareholders to have a general authority from the Shareholders to enable the Directors to buy back Shares. Such buy-backs may, depending on market conditions and funding arrangements at the time, lead to an enhancement in the value of the Shares and/or earnings per Share and will only be made when the Directors believe that such buy-backs will benefit the Company and the Shareholders.

3. FUNDING OF BUY-BACKS

In buying back Shares, the Company may only apply funds legally available for such purpose in accordance with the Articles of Association and the applicable laws of the Cayman Islands.

In the event that the Buy-back Mandate is exercised in full, there might be a material adverse impact on the working capital and/or gearing position of the Company (as compared with the position disclosed in the Company's Annual Report and financial statements for the year ended 31 December 2022). However, the Directors do not propose to exercise the Buy-back Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or gearing level which in the opinion of the Directors is from time to time appropriate to the Company.

4. UNDERTAKING

The Directors have undertaken to the Stock Exchange that they will exercise the powers of the Company to make buy-backs pursuant to the Buy-back Mandate and in accordance with the Listing Rules and the applicable laws of the Cayman Islands.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their close associates, has any present intention to sell any Shares to the Company or its subsidiaries under the Buy-back Mandate if such mandate is approved by the Shareholders.

6. THE TAKEOVERS CODE AND MINIMUM PUBLIC HOLDING

If, as a result of the buy-back of Shares by the Company, a Shareholder's proportionate interest in the voting rights of the Company increases, such increases will be treated as an acquisition of voting rights for the purposes of Rule 32 of the Takeovers Code. Accordingly, a Shareholder, or a group of Shareholders acting in concert, depending on the level of increase of the Shareholder's interest, may obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 and Rule 32 of the Takeovers Code.

As at the Latest Practicable Date, CSC, through its wholly-owned subsidiary, owned 1,596,403,279 Shares, representing approximately 70.78% of the issued share capital of the Company. CSC is a subsidiary of COHL which, in turn, is wholly-owned by CSCECL. CSCECL is, in turn, a subsidiary of CSCEC.

APPENDIX II EXPLANATORY STATEMENT FOR THE BUY-BACK MANDATE

In the event that the Buy-back Mandate is exercised in full, then (if the present shareholdings remained the same) the interest of CSC (held through its wholly-owned subsidiary) would be increased to approximately 78.64% of the then issued share capital of the Company. In the opinion of the Directors, such increase will not give rise to any obligation to make a mandatory offer under Rule 26 of the Takeovers Code. The Board will endeavour to ensure that the exercise of the Buy-back Mandate will not result in less than 25% of the issued share capital of the Company, being the minimum prescribed public float requirement under the Listing Rules, being held in the hands of the public.
