- conducting or assisting to conduct signature verification, and any other verification or exchange of information;
- distributing communications from Long Thrive and/or their subsidiaries or agents such as Goldin Equities and the Registrar;
- compiling statistical code information and shareholder profiles;
- making disclosures as required by laws, rules or regulations (whether statutory or otherwise);
- disclosing relevant information to facilitate claims on entitlements;
- any other purpose in connection with the business of Long Thrive or the Registrar;
- any other incidental or associated purposes relating to the above and any other purposes to which the shareholders of H Shares may from time to time agree to or be informed of.

# 3. Transfer of personal data

The personal data provided in this Form of Acceptance will be kept confidential but Long Thrive and/or the Registrar may, to the extent necessary for achieving the purposes above or any of them, make such enquiries as they consider necessary to confirm the accuracy of the personal data and, in particular, they may disclose, obtain, transfer (whether within or outside Hong Kong) such personal data to, from or with any and all of the following persons and entities:

- Long Thrive, their subsidiaries and/or agent(s), such as Goldin Equities and the Registrar;
- any agents, contractors or third party service providers who offer administrative, telecommunications, computer, payment or other services to the Registrar in connection with the operation of its business;
- any regulatory or governmental bodies;
- any other persons or institutions with which you have or propose to have dealings, such as their bankers, solicitors, accountants, licensed securities dealers or registered institutions in securities;
- any other persons or institutions whom Long Thrive and/or the Registrar consider(s) to be necessary or desirable in the circumstances.

#### 4. Access and correction of personal data

The Ordinance provides you with rights to ascertain whether Long Thrive and/or the Registrar hold your personal data, to obtain a copy of that data, and to correct any data that is incorrect. In accordance with the Ordinance, Long Thrive and the Registrar have the right to charge a reasonable fee for the processing of any data access request. All requests for access to data or correction of data or for information regarding policies and practices and the kinds of data held should be addressed to Long Thrive or the Registrar (as the case may be).

# 1. 收集 閣下個人資料的原因
