4. A member entitled to attend and vote at the meeting is entitled to appoint a proxy to attend and, on a poll, vote on his behalf. A proxy does not need to be a member of the Company.

IF YOU WISH TO ABSTAIN FROM VOTING FOR A RESOLUTION, PLEASE TICK ("√") THE BOX MARKED "ABSTAIN" BESIDE THE RESOLUTION. If the form returned is duly signed but without specific direction on any of the proposed resolutions, the proxy will vote or abstain at his discretion in respect of all resolutions; or if in respect of a particular proposed resolution there is no specific direction, the proxy will, in relation to that particular proposed resolution, vote or abstain at his discretion.
6. This amended form of proxy must be signed by you or your attorney duly authorised in writing, or if you are a corporation, must either be executed under seal or under the hand of an officer, attorney or other person duly authorised.

To be valid, this amended form of proxy and, if such amended proxy form is signed by a person under a power of attorney or authority on behalf of the appointer, a notarially certified power of attorney (if any) or other authority (if any) under which it is signed, must be deposited at the Company's H Shares registrar and transfer office at Tricor Investor Services Limited, 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong (for holders of H Shares only) or at the Company's registered office at No. 36, Bei San Dong Road, Shihezi Economic and Technological Development Zone, Shihezi, Xinjiang, the PRC (for holders of Domestic Shares only), not less than 24 hours before the time appointed for holding the AGM or any adjournment thereof. Completion and return of the amended form of proxy will not preclude you from attending and voting at the AGM or any adjourned meeting should you so wish.

Where there are joint holders of any Share, any one of such persons may vote at the AGM either personally, or by proxy, in respect of such Share as if he were solely entitled thereto, and if more than one of such joint holders be present at the AGM personally or by proxy, then one of the said persons so present whose name stands first on the register of members of the Company shall alone be entitled to vote.
9. Completion and delivery of this amended form of proxy will not preclude you from attending and voting at the AGM or any adjournment thereof if you so wish.
10. This amended form of proxy is for the resolutions contained herein only.
11. For Shareholders who intend to attend the AGM by proxy, if the form of proxy (the "Original Proxy Form") sent together with the circular and the notice of the AGM of the Company dated 30 April 2024 has not been lodged, then only the Amended Proxy Form shall be lodged and the Original Proxy Form needs not to be lodged. Shareholders who have lodged the Original Proxy Form shall note that:
 - (i) If the Amended Proxy Form is lodged 24 hours before the time designated for convening the AGM or any adjourned meeting thereof (the "Closing Time") by the Shareholders, it will revoke and supersede the Original Proxy Form previously lodged. The Amended Proxy Form, if duly completed, will be treated as a valid form of proxy lodged by such Shareholder; and
 - (ii) If no Amended Proxy Form is lodged before the Closing Time by the Shareholders, the Original Proxy Form lodged, if duly completed, will remain valid. The proxy so appointed pursuant to the Original Proxy Form will be entitled to vote in accordance with the instructions previously given by the Shareholder or at his/her discretion (if no such instructions are given) on any resolution properly put to the AGM, including the corrected special resolution in item 10 as set out in this Amended Notice.
