HELD ON 18 JUNE 2021

The annual general meeting (the “AGM”) of Zhongsheng Group Holdings Limited (the “Company”) was held at 11:00 a.m. on Friday, 18 June 2021 at Room 1803–09, 18/F, Sun Hung Kai Centre, 30 Harbour Road, Wanchai, Hong Kong. The AGM was chaired by Mr. Huang Yi, the chairman of the Company.

A total of eight shareholders of the Company (the “Shareholder(s)”) and duly authorised representatives, holding 2,068,144,166 shares of the Company representing approximately 89.321842% of the total number of issued shares of the Company, were present at the AGM. All the proposed resolutions as set out in the notice of the AGM dated 23 April 2021 were duly passed by way of poll at the AGM and the poll results are as follows:

As at the date of the AGM, the number of issued shares of the Company was 2,315,384,591, which was the total number of shares entitling the Shareholders to attend and vote for or against the resolutions at the AGM. There were no shares of the Company entitling the Shareholders to attend and abstain from voting in favour of the resolutions proposed at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and no Shareholder were required under the Listing Rules to abstain from voting at the AGM. There were no restrictions on any Shareholders casting votes on the resolutions proposed at the AGM. No party has stated his or her intention in the Company’s circular dated 23 April 2021 to vote against the resolutions proposed at the AGM or to abstain from voting.

The Company’s branch share registrar, Computershare Hong Kong Investor Services Limited, acted as the scrutineer for the poll at the AGM.

### **DISTRIBUTION DATE OF FINAL DIVIDEND**

As approved by the Shareholders at the AGM, the board of directors of the Company (the “**Board**”) is pleased to announce that the Company will distribute a final dividend of HK\$0.58 per share for the year ended 31 December 2020 to Shareholders whose names are listed in the register of members of the Company on Monday, 28 June 2021. For determining the entitlement to the final dividend, the register of members of the Company will be closed from Thursday, 24 June 2021 to Monday, 28 June 2021, both days inclusive, and the final dividend will be distributed on Monday, 12 July 2021.
