MANAGEMENT'S REPORT 管理層報告

On behalf of the board of directors (the "Board") of China Environmental Resources Group Limited (the "Company"), I am pleased to present the Annual Report 2016 and the audited consolidated financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 30 June 2016.

BUSINESS AND OPERATION REVIEW

The Group was listed in 1997 with business focuses on garment and property businesses in the People's Republic of China ("PRC"). Due to keen competition and rising cost of the garment and property businesses, the Group diversified into green business in late 2008. Due to the unstable natural factors, the Group diversified into money lending business, car parking spaces rental, motor trading and trading and investment business in 2015 and 2016.

The Group is currently engaged in motor trading, car parking spaces rental, money lending business and trading and investment business. The Group also maintains the green businesses of research, development and application of technologies solutions, manufacture, sale and trading of products, systems and services for green market segments including the environmental markets, agricultural markets, organic markets and green technology markets in the PRC market and overseas. The Group has been continuing to explore new business opportunities for corporate development and dedicates to develop sustainable current business.

The Group operates approximately 30,000 mu (Chinese Mu) of the plantation in Shihezi City, Xinjiang. The underground water level of the region dropped drastically in recent years due to over-exploitation of farmland, resulting in a shortage of water resources. The irrigation in Xinjiang relies heavily on underground water, because the supply of surface water is far below the demand for plantation irrigation, thus creating difficulties for hydraulic engineering projects for plantation areas and driving up the operating costs.

As the construction industry in China is shrinking, the demand for housing construction materials decreases and the prices of timber are going downward in short-term. Therefore, the Group adopted a conservative investment approach towards its plantation management, under which the Group reduced its investment in reforestation and only conducted basic maintenance measures.

The Group acquired a subsidiary which directly holds, inter alia, 95 car parking spaces located in Kennedy Town, Hong Kong during the financial year ended 30 June 2016. In view of recent surge in market price of car parking spaces in Hong Kong, the prospect of car parking spaces in Hong Kong to be positive. The car parking spaces rental can be broaden the Group's source of income.

本人謹此代表中國環境資源集團有限公司(「本 公司」)董事會(「董事會」)向股東呈報二零一六 年年報及本公司及其附屬公司(統稱「本集團」) 截至二零一六年六月三十日止年度之經審核綜 合財務報表。

業務及營運回顧

本集團於一九九七年上市,業務重點為於中華 人民共和國(「中國」)經營服裝及物業業務。由 於服裝及物業業務競爭激烈且成本不斷增加, 本集團於二零零八年底擴展至綠色業務。基於 自然因素不穩定,本集團於二零一五年及二零 一六年開拓業務至借貸業務、停車位租賃、買 賣汽車及買賣及投資業務。

本集團目前從事汽車買賣、停車位租賃、借貸 業務以及買賣及投資業務。本集團亦繼續從事 中國及海外綠色市場(包括環保市場、農業市 場、有機市場及綠色技術市場)技術與解決方 案的研發及應用、生產、銷售及買賣相關產 品、系統及服務等綠色業務。本集團不斷為公 司發展探尋新商機以及致力發展可持續的現有 業務。

本集團經營位於新疆石河子約30,000畝(中國 畝)的農地。由於區內農田過度開墾,近年地 下水位下降嚴重,水資源緊缺。新疆主要以地 下水灌溉,地表水遠不能滿足種植上的要求, 造成林帶水利工程的困難及經營成本的上漲。

中國建造業的萎縮,建房用材需求減少,木材 價格呈短期下降趨勢。故本集團對林帶管理採 取較保守的投資策略,其中包括減少更新造林 的投入,及只作基本的維護措施。

於截至二零一六年六月三十日止財政年度,本 集團收購一間附屬公司,其直接持有(其中包括)95個位於香港堅尼地城的停車位。鑑於香 港停車位市價近期急升,香港停車位的前景可 觀。停車位租賃可拓寬本集團的收入來源。

The Group has launched its motor trading business during the financial year ended 30 June 2016 by introducing the world's first road legal, within a captivating package of formula car-inspired technology remarkable performance, breath-taking design and ultra light-weight single seat supercar "BAC Mono". The Group also launched its trading in a United Kingdom motorcycle marque "Norton" which is highly regarded road motorcycle.

Although global economy will still be uncertain and volatile in coming years, the luxury goods market, especially the supercar segment is stable and rising. The Group is of the view that the motor trading business will bring positive contribution to the Group and will allocate appropriate resource to further develop this business segment.

For the financial year ended 30 June 2016, turnover of the Group increased by 390% to approximately HK\$13.37 million with gross profit of approximately HK\$5.15 million (2015: turnover of approximately HK\$2.73 million with gross profit of approximately HK\$0.93 million). Loss for the year amounted to HK\$106.89 million (2015: Loss of approximately HK\$68.9 million), including mainly the increase of approximately HK\$33.16 million in the net loss on fair value changes on financial assets at fair value through profit or loss.

BIOLOGICAL ASSETS

In the process of valuing the Biological Asset, Roma adopted the Market-Based Approach to estimate the fair value of the Biological Asset. The fair value of the Biological Asset was computed using the formula:

The fair value of Biological Asset = (Total volume of standing timbers × Recovery rate) × Market price of timber – Cutting cost + Scrap sale income

According to 農業資產估值報告 prepared by Forestry Manager, random sampling has been performed on 31 July 2016, in order to estimate the total volume of standing timbers on the Plantation Land based on "中華人民共和國國家標準原木材積表 GB/T 4814-2013". During the sampling process, there were 20 sampling areas with an area of about 0.5 Mu. The following inputs have been adopted in this valuation based on the opinions as stated in 農業資 產估值報告 prepared by Forestry Manager:

- Total volume of standing timbers = 818,455 m³
- Recovery rate = 80%

於截至二零一六年六月三十日止財政年度,本 集團推出其汽車貿易業務,引入世界首輛合法 於道路行駛的「BAC Mono」超級單座跑車,其 外形亮麗,具備方程式賽車技術的高性能表 現,設計精緻且極為輕巧。本集團亦開始買賣 英國電單車品牌「Norton」,其公路電單車大獲 好評。

儘管來年全球經濟仍不明朗且反復不定,惟奢 侈品市場(尤其對於超級跑車分部而言)呈現穩 步增長態勢。本集團認為,汽車貿易業務將為 本集團帶來正面貢獻,從而得以分配適當資源 進一步發展該項業務分部。

截至二零一六年六月三十日止財政年度,本集 團的營業額增加390%至約13,370,000港元, 毛利約為5,150,000港元(二零一五年:營業 額約為2,730,000港元,毛利約為930,000港 元)。年內虧損達106,890,000港元(二零一五 年:虧損約68,900,000港元),主要包括因按 公允值計入損益之金融資產公允值變動之虧損 淨額增加約33,160,000港元。

生物資產

於生物資產估值過程,羅馬國際已採用市場基礎法以估計生物資產公允值。生物資產公允值 按以下算式計算:

生產資產之公允值=(未採伐林木總量×採收率) ×木材市價-砍伐成本+廢料銷售收入

根據林木經理編製之農業資產估值報告,於二 零一六年七月三十一日,已根據「中華人民共 和國國家標準原木材積表GB/T 4814-2013」隨 機抽樣,以估計種植土地之未採伐林木總量。 於抽樣過程中,共有20個面積為約0.5畝之抽 樣地區。根據林木經理編製之農業資產估值報 告所載意見,本估值已採納以下輸入數據:

- 未採伐林木總量= 818,455立方米
- 採收率= 80%



- Cutting cost = 5% of revenue
- Scrap sale income = 5% of revenue

With reference to observable market price of timber of similar species in China, the adopted market price was RMB716 per cubic meter.

To determine how the different values of an independent variable would impact a particular dependent variable under a given set of assumptions, Roma carried out sensitivity analyses on the fair value of the Biological Asset in respect of the recovery rate and adopted market price. The results of the sensitivity analyses were as follows:

- 砍伐成本=收益之5%

為釐定於一組特定假設下自變項之數值不同對 某一因變項之影響,羅馬國際就採收率及所採 納市價對生產資產公允值進行敏感度分析。敏 感度分析結果如下:

The directors are of the view that the fair value of the biological assets are under a significant impact from changes in market price per m³ of logs. If the market price per m³ of logs increases/ decreases, the fair value of the biological assets would be higher/ lower proportionately, holding other inputs and assumptions used in the valuation techniques remained unchanged.

During the financial year 30 June 2016, the Group recognised aggregate losses arising from the major non-current assets of approximately HK\$51 million. This represents the combined effect of the amortisation of intangible asset and the loss arising from changes in fair value less costs to sell of biological assets.

董事認為,生物資產公允值因每立方米原木市 價變動而受到重大影響。在估值技巧所用其他 輸入數據及假設保持不變的情況下,倘每立方 米原木市價增加/減少,則生物資產的公允值 將按比例增加/減少。

於截至二零一六年六月三十日止財政年度,本 集團確認來自主要非流動資產之虧損總額約 51,000,000港元,代表攤銷無形資產及生物資 產公允值變動減銷售成本產生之虧損之合併影 響。

MOTOR TRADING

In view of an increasing demand of supercars in Hong Kong, on 10 August 2015, the Group firstly commenced its distribution business of specialist sport cars of United Kingdom brand and extended the scope with motorcycles and accessories. At the second quarter of 2016, the Group further commenced to distribute United Kingdom and Italian Brands motorcycles and related accessories. For the financial year ended 30 June 2016, the sales of trading of motor vehicles and motorcycles recorded HK\$9.68 million (2015: Nil).

CAR PARKING SPACES RENTAL

On 3 July 2015, the Group completed a major and connected transaction, namely, the acquisition of the entire issued share capital and shareholder's loan of the newly acquired subsidiary which directly holds, inter alia, 95 car parking spaces located in Kennedy Town, Hong Kong. For the financial year ended 30 June 2016, rental income recorded was approximately HK\$3.36 million (2015: Nil).

MONEY LENDING BUSINESS

On 18 December 2014, the Group obtained the money lenders license. The directors of the Company consider it will be beneficial to the Group to explore new opportunities in the money lending business to broaden its source of income and expand the business operations in order to generate profits and return for the Company and the Shareholders. For the financial year ended 30 June 2016, loan interest income recorded approximately HK\$0.33 million (2015: HK\$0.01 million).

TRADING AND INVESTMENT BUSINESS

In view of the launch of Shanghai-Hong Kong Stock Connect and to have a better utilization of the Group's funding resources, the Group started trading in securities in Year 2014. The Group's trading securities are measured at fair value, which are based on their quoted prices in the securities market and the securities market was very volatile in July and August 2015. The volatility of the securities market may have adverse effect to the performance of the Group after the year ended 30 June 2016. For the financial year ended 30 June 2016, the net loss on fair value changes on financial assets at fair value through profit or loss recorded HK\$33.16 million (2015: net gain HK\$30.85 million).

汽車買賣

鑑於香港對超級跑車的需求愈來愈高,於二零 一五年八月十日,本集團首次展開其英國品牌 的專業運動車分銷業務,並加入電單車及配件 範疇。於二零一六年第二季,本集團進一步展 開其分銷英國及意大利品牌電單車及相關配件 業務。截至二零一六年六月三十日止財政年 度,買賣汽車及電單車錄得9,680,000港元的銷 售額(二零一五年:無)。

停車位租賃

於二零一五年七月三日,本集團完成一項主要 及關連交易,即收購新收購附屬公司之全部已 發行股本及股東貸款,該公司直接持有(其中 包括)位於香港堅尼地城之95個停車位。截至 二零一六年六月三十日止財政年度,租賃收入 錄得約3,360,000港元(二零一五年:無)。

借貸業務

於二零一四年十二月十八日,本集團取得放債 人牌照。本公司董事認為這將對本集團有利, 可發掘放債業務的新機遇,擴闊其收入來源及 拓展業務營運,藉此為本公司及股東帶來利潤 及回報。截至二零一六年六月三十日止財政年 度錄得貸款利息收入約330,000港元(二零一五 年:10,000港元)。

買賣及投資業務

鑑於實行滬港通及為了更加善用本集團的資金 資源,本集團於二零一四年度開展證券買賣。 本集團之證券買賣按公允值計量,即以證券市 場之報價為基礎,且證券市場於二零一五年七 月及八月大幅波動。證券市場波動可能對本集 團於截至二零一六年六月三十日止年度後之表 現造成不利影響。於截至二零一六年六月三十 日止財政年度,按公允值計入損益之金融資產 之公允值變動虧損淨額錄得33,160,000港元 (二零一五年:收益淨額30,850,000港元)。



PLANTATION PRODUCT

There was no revenue on the sale of plantation products for the year (2015: Nil).

For the financial year ended 30 June 2016, the growth and the volume of the biological assets was affected by the shortage of underground water in the region. The Group recorded the decrease by 13.70% to approximately HK\$547.22 million (2015: approximately HK\$634.12 million) in the fair value of the poplar trees of biological assets. The Group considers that the decreases are non-cash in nature and will not have material adverse effect on the financial position of the Group.

GREEN TECHNOLOGY

The green technology segment comprises the research and development, project establishment, application and sale of green and environmental product, technology, service and related products for sustainable development. There was no revenue on the green technology segment for the year (2015: sales approximately HK\$2.7 million, accounting for about 98.79% of the Group's total revenue).

PROSPECTS

In view of the challenging economic and business environment, the management of the Group continued to review its existing businesses from time to time and strived to improve the business operation and financial position of the Group.

In this regards, on 3 July 2015, the Group completed a major and connected transaction, namely, the acquisition of the entire issued share capital and shareholder's loan of the newly acquired subsidiary which directly holds, inter alia, 95 car parking spaces located in Kennedy Town, Hong Kong. The acquisition generated stable and continuous income and cash flow to the Group. The Group is considering to enhance the value of the car parking spaces and maximize the return of the Group.

In addition, at August 2015, the Group commenced its motor trading business including distribution of United Kingdom brand of supercar; and United Kingdom and Italian Brands motorcycles and related accessories. This business segment became major revenue generator for the financial year ended 2016 and the Group will continue to allocate more resource and effort to develop this segment.

It has been the business strategy of the Group to proactively seek potential investment opportunities in order to enhance value of the shareholders of the Company. The directors of the Company consider that it is beneficial for the Group to seek suitable investment opportunities from time to time to diversify its existing business portfolio into new line of business with growth potential and to broaden its source of income.

種植產品

銷售種植產品於本年度並無錄得收益(二零 一五年:無)。

截至二零一六年六月三十日止財政年度, 生物資產的增長及數量受區內地下水短缺 影響。本集團的楊樹生物資產公允值減少 13.70%至約547,220,000港元(二零一五年:約 634,120,000港元)。本集團認為該減少屬非現 金性質,故此不會對本集團的財務狀況造成重 大不利影響。

綠色技術

緣色技術分部包括綠色及環保產品、技術、服務及有關可持續發展產品的研發、項目建立、應用及銷售。銷售綠色技術分部於本年度並無錄得收益(二零一五年:銷售約2,700,000港元,佔本集團總收益約98.79%)。

前景

鑑於經濟及營商環境充滿挑戰,本集團管理層 持續不時檢討其現有業務,致力改善本集團之 業務營運及財務狀況。

就此方面,於二零一五年七月三日,本集團完 成一項主要及關連交易,即收購新收購附屬公 司之全部已發行股本及股東貸款,該公司直接 持有(其中包括)位於香港堅尼地城之95個停車 位。該收購為本集團產生穩定及持續收入及現 金流。本集團正考慮提高停車位價值以為本集 團帶來最大回報。

此外,於二零一五年八月,本集團展開買賣汽 車業務,包括分銷英國品牌超級跑車及英國和 意大利品牌電單車及汽車相關配件。該業務分 部於二零一六年財政年度成為主要收益來源, 而本集團將繼續分配更多資源及精力發展該分 部。

本集團之業務策略為積極尋求潛在投資機會, 以提升本公司股東的價值。本公司董事認為, 本集團不時尋求合適投資機會,將其現有業務 組合多元化拓展至具有增長潛力之新業務範圍 及擴闊其收入來源,對本集團有利。

MANAGEMENT'S REPORT 管理層報告

FINANCIAL REVIEW

For the year ended 30 June 2016, the Group recorded a consolidated revenue at approximately HK\$13.37 million (2015: approximately HK\$2.73 million), representing an increase of 390% as compared with the year ended 30 June 2015 (the "Previous Year"). The Group's gross profit increase by 454% to approximately HK\$5.15 million (2015: approximately HK\$0.93 million). The increase in both consolidated revenue and gross profit were mainly due to the newly launched motor trading business and car park spaces rental.

The loss for the year increased to approximately HK\$106.89 million from Previous Year's loss of approximately 68.9 million.

In calculating the Group's consolidated net loss, the administrative expenses of approximately HK\$49.3 million (2015: approximately HK\$41.42 million) included major items, such as staff costs of approximately HK\$15.36 million, depreciation of approximately HK\$6.31 million, amortisation of intangible assets of approximately HK\$5 million, auditor's remuneration of approximately HK\$0.78 million, operating leases charges of approximately HK\$5.12 million and forestry maintenance fee of HK\$4 million charged by the Group's forestry manager.

Finance costs of HK\$0.66 million which was mainly recorded for interests on promissory note. Income tax credit was approximately HK\$16.7 million (2015: approximately HK\$15.7 million) mainly due to deferred tax credit of approximately HK\$17.1 million (2015: approximately HK\$16.17 million).

LIQUIDITY AND FINANCIAL RESOURCES

As at 30 June 2016, the total assets of the Group was approximately HK\$998.93 million (2015: approximately HK\$985.80 million), including cash and bank balances of approximately HK\$81.36 million (2015: approximately HK\$57.62 million). The directors of the Company are of the view that the Group has sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due in the foreseeable future.

CAPITAL RAISING AND EXPENDITURE

As at 30 June 2016, details of movements in the issued share capital of the Company is stated in note 28 to the consolidated financial statements.



財務回顧

截至二零一六年六月三十日止年度,本集團錄 得綜合收益約13,370,000港元(二零一五年: 約2,730,000港元),較截至二零一五年六月 三十日止年度(「上年度」)增加390%。本集 團的毛利增加454%至約5,150,000港元(二零 一五年:約930,000港元)。綜合收益及毛利均 告增加,主要由於新開展的買賣汽車業務及停 車位租賃。

年內虧損由上年度之虧損約68,900,000港元增 加至約106,890,000港元。

計算本集團綜合虧損淨額時,行政開支約 49,300,000港元(二零一五年:約41,420,000 港元)包括主要項目,例如僱員成本約 15,360,000港元、折舊約6,310,000港元、無 形資產攤銷約5,000,000港元、核數師酬金約 780,000港元、經營租賃費用約5,120,000港 元及由本集團林木經理收取之林木維護費用 4,000,000港元。

承兑票據利息主要錄得融資成本660,000港 元。所得税抵免約為16,700,000港元(二零 一五年:約15,700,000港元),主要由於遞延 税項抵免約17,100,000港元(二零一五年:約 16,170,000港元)所致。

流動資金及財務資源

於二零一六年六月三十日,本集團總資產約為998,930,000港元(二零一五年:約985,800,000港元),其中包括現金及銀行結餘約81,360,000港元(二零一五年:約57,620,000港元)。本公司董事認為本集團有充足營運資金以支持其持續經營並有能力償還於可預見未來內到期之財務責任。

集資及資本開支

於二零一六年六月三十日,有關本公司已發行 股本之變動詳情列載於綜合財務報表附註28。



BUSINESS ACQUISITION AND DISPOSAL

As at 30 June 2016, apart from those as in note 30 and 31 to the consolidated financial statements, there was no major acquisition or disposal undertaken by the Group.

EMPLOYMENT AND REMUNERATION POLICY

As at 30 June 2016, the Group had 27 employees (2015: 23 employees) in both Hong Kong and the PRC. On 26 March 2015, Prima Choice Limited, a wholly-owned subsidiary of the Company, as purchaser, had entered into a sale and purchase agreement with Fortune Group Investment Limited (1st Vendor) and Winbo Property Limited (2nd Vendor), pursuant to which (i) the Vendors have conditionally agreed to sell and the Purchaser has conditionally agreed to acquire the Sale Shares; and (ii) the Vendors have conditionally agreed to sell and assign and the Purchaser has conditionally agreed to take up an assignment of the Sale Loan. The Transaction Consideration for the Acquisition will be satisfied by a combination of cash and by issue of the Promissory Note by the Company. Upon Completion, the Target Company will become an indirect wholly-owned subsidiary of the Company. The completion took place on 3 July 2015.

Mrs. Ma Shu Chin, mother of Mr. Yeung Chi Hang, an executive Director, the Chairman and chief executive officer of the Company owned 60% of each of the 1st Vendor and 2nd Vendor, therefore both Vendors are connected persons of the Company as defined under the Listing Rules. As some of the applicable percentage ratios (as defined under the Listing Rules) in respect of the Acquisition exceed 25% but below 100%, the Acquisition constitutes a major and connected transaction of the Company and is therefore subject to the reporting, announcement, circular and the Independent Shareholders' approval requirements under Chapter 14 and Chapter 14A of the Listing Rules.

CONTINUING CONNECTED TRANSACTIONS

The Company has entered into the following continuing connected transaction which is subject to disclosure requirement in the annual report under the Listing Rules:

On 6 August 2015, International Richway Limited, a wholly-owned subsidiary of the Company, as tenant, has entered into the Tenancy Agreement with High Brand Limited as landlord, in respect of the leasing of the Property for a term of 11 months and 26 days commencing from 6 August 2015 with a rental of HK\$166,075 per month. Several measures have been implemented by the Group in order to promote environmental protection, including, among others:

- promoting energy saving by encouraging its staff to switch off all air-conditioners and lightings before leaving the office, and to utilise the timer-control function of all air-conditioning systems;
- (ii) reducing energy consumption by using energy-saving light bulbs in the corridors and the reception area of its offices;
- (iii) promoting recycling by placing recycle bins next to printers for collecting used papers for reusing and recycling purposes, and by encouraging two-sided printing and/or the use of scratch papers;
- (iv) reducing the use of disposable products by, for example, cancelling the distribution of plastic bags in office; and
- (v) reducing water consumption by replacing all water taps by automatic faucets in offices.

COMPLIANCE WITH LAWS AND REGULATIONS

During the year ended 30 June 2016 and up to the date of this report, we have complied with all the relevant laws and regulations in the mainland China and Hong Kong that have a significant impact on the Group.

DONATIONS

During the year, the Group did not make any charitable donations.

Save for the share option schemes as disclosed in the Annual Report, no equity-linked agreement was entered into during the year or subsisted at the end of the year.

Pursuant to the Company's articles of association, every Director shall be entitled to be indemnified out of the assets of the Company against all losses or liabilities incurred or sustained by him as a Director, in defending any proceedings, whether civil or criminal, in which judgment is given in his favour, or in which he is acquitted. The Company has taken out insurance against the liability and costs associated with defending any proceedings which may be brought against Directors of the Group.

MAJOR CUSTOMERS AND SUPPLIERS

In the year under review, the sales to the Group's five largest customers accounted for approximately 83% of the total sales for the year and the sales to the largest customer included therein amounted to 26%. Purchases from the Group's five largest suppliers accounted for approximately 91% of the total purchases for the year and the purchase from the largest supplier included therein amounted to approximately 52%.

None of Directors, any of their associates or any substantial Shareholders (which, to the best knowledge of the Directors, own more than 5% of the Company's issued share capital) had any beneficial interest in the Group's five largest customers or five largest suppliers.

RELATIONSHIPS WITH EMPLOYEES, SUPPLIERS AND CUSTOMERS

The Group's management policies, working environment, career prospects and employees' benefits have contributed to building a good employee relations and employee retention of the Group. The Group offers competitive remuneration packages commensurate with industry practice and provides various fringe benefits to employees including medical benefits, social insurance, provident funds, bonuses and a share option scheme. The management regularly reviews its employee's remuneration packages to ensure they are up to prevailing market standard.

The Group keeps a high standard in selecting reputable and reliable suppliers, in order to meet our own quality, safety, environmental and product criteria. During the year ended June 2016 and up to the date of this report, the Group maintained good relationship with its suppliers. The Group has a well-established business relationship with the customers.

PRE-EMPTIVE RIGHTS

There are no provisions for pre-emptive rights under the Articles of Association, or the Companies Law of the Cayman Islands, which would oblige the Company to offer new shares on a pro-rata basis to existing shareholders.

PUBLIC FLOAT

As at the date of this report, the Company has maintained a sufficient public float under the Listing Rules, based on the information that is publicly available to the Company and within the knowledge of Directors.

USE OF PROCEEDS FROM PLACING

The Group successfully raised over HK\$46.67 million through the Placing Shares to not less than six independent Placees at the Placing Price of HK\$0.165 per Placing Share on 13 May 2016 in order to enlarge capital base, strengthen the Group's financial position for future development and working capital position. The Placing Price of HK\$0.165 per Placing Share represents (i) a discount of approximately 18.32% to the closing price of HK\$0.202 per Share as quoted on the Stock Exchange on 26 April 2016, being the date of the Placing Agreement; and (ii) a discount of approximately 19.51% to the average closing price of HK\$0.205 per Share as quoted on the Stock Exchange for the five consecutive trading days up to and including 25 April 2016.

Upon the completion of the Placing, the Company received a gross proceeds of approximately HK\$46.67 million and a net proceeds from the Placing, after deducting relevant expenses incurred in relation to the Placing, amount to approximately HK\$45.61 million. As at 30 June 2016, the Group has not utilized any of the net proceeds from such Placing. The unutilized portion of the net proceeds is currently held in cash and cash equivalents and it is intended that it will be applied in the manner consistent with the intended use of proceeds as disclosed in the Company's announcement dated 26 April 2016.

The Board is committed to maintain and ensure high standards of corporate governance practice. The Company stresses the importance of maintaining the quality of the Board by ensuring that the Directors possess a wide range of expertise and the effective implementation of an accountability system, so as to ensure that business activities and decision making processes are regulated in a proper manner.

The Company has complied with the code provisions as set out in the Corporate Governance Code (the "CG Code") contained in Appendix 14 to the Rule Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") for the year ended 30 June 2016, except the followings:

Code provisions A.2.1 of the CG Code provides that the roles of chairman of the board and chief executive should be separate and should not be performed by the same individual. This code provisions also stipulate, inter alia, the role and responsibility of the chairman of the board and the chief executive.

Mr. Yeung Chi Hang was appointed as chairman of the Board and the chief executive officer of the Company on 27 January 2015. Thereafter, Mr. Yeung Chi Hang has assumed both roles, The directors were of the view that the vesting of the roles of chairman of the Board and chief executive officer in the same person can provide the Group with strong and consistent leadership and allow for more effective planning and execution of long-term business strategies, as well as ensuring effective oversight of management. The directors were also of the view that the present structure was considered to be appropriate under the circumstances of the Company. The Board would keep review of its current board stricture from time to time.

Code provision E.1.2 of the CG Code stipulates that the chairman of the board should attend the annual general meeting. Mr. Yeung Chi Hang was unable to attend the annual general meeting of the Company held on 11 November 2015 due to business trips. The Board and each Director have separate and independent access to the Company's senior management for information and making enquires if necessary. A Director, who considers there is necessary to seek independent professional advice in order to perform his duties as a Director, may convene, or request the company secretary of the Company (the "Company Secretary") to convene, a Board meeting to approve the consultation of independent legal or other professional adviser for advice at the Company's expenses.

For regular Board meeting, a notice of the meeting is sent to all Directors at least 14 days before the intended date of meeting and an agenda and accompanying board papers of the meeting are sent to all Directors at least three days before the intended date of meeting. For all other Board meeting, a notice of the meeting together with an agenda and accompanying board papers of the meeting are sent to all Directors in reasonable time. The Directors also from time to time transact the Board business by way of written resolutions.

Every Director is entitled to have access to the advice and service of the Company Secretary with a view to ensure that the Board procedures and applicable rules and regulations are complied with. All minutes are kept by the Company and are open for inspections by any Director during normal office hours by giving reasonable advance notice. Minutes of the Board meetings and the Board committee meetings record in sufficient details the matters considered in the meetings and decisions reached. Draft and final versions of minutes of the Board meetings and Board committee meetings have been sent to all Directors and relevant Board Committee members for their comments and records respectively within a reasonable time after the relevant meetings were held.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The Chairman of the Board and the Chief Executive Officer have different roles. The Chairman of the Board is responsible for the operation of the Board and the Chief Executive Officer is responsible for managing the operations and day-to-day management of the Group. Their functions have been clearly divided to ensure a balanced distribution of power and authority not concentrating on a single individual.

The Chairman of the Board shall ensure the Board operates effectively and performs its proper duties and discusses all important and proper matters in a timely manner. The Chairman of the Board is responsible for convening Board meetings, consulting, determining and approving the agenda of each Board meeting, and ensuring that Directors are provided sufficient information on current matters in a timely manner.

The Chief Executive Officer is principally responsible for the daily operation and management of the Group's overall operations and implementing the Board's operating strategy and policy and delegating tasks to all departments for implementation so as to realize the Board's objectives and decisions. APPOINTMENT AND RE-ELECTION OF DIRECTORS

In accordance with the CG Code and the Articles of Association, all Directors, including Independent Non-executive Directors, are subject to retirement by rotation once every three years. Composition of the Board will be reviewed regularly by the Board and also by the nomination committee of the Company to ensure that it covers a balance of expertise, skills and experience appropriate for the requirements of the business of the Company.

Pursuant to the Article of Association, Mr. Yeung Chi Hang, Mr. Wong Kwai Sang and Mr. Ong Chi King, being the existing Directors longest in office since their last re-election, will retire by rotation and being eligible offer themselves for re-election and Mr. Chik To Pan, the newly appointed Director, will retire at the forthcoming annual general meeting of the Company and being eligible, offers himself for re-election.

Each Director had entered into an appointment letter with the Company setting out the key terms and conditions of his appointment. All Independent Non-executive Directors are appointed for a specific term, subject to retirement by rotation under the Articles of Association. The term of office of Mr. Wong Kwai Sang, Mr. Ong Chi King and Mr. Heung Chee Hang, Eric as Independent Non-executive Director is for three years until 1 March 2018, 27 January 2017 and 16 January 2018 respectively.

The Board has received from each Independent Non-executive Director a written annual confirmation of his independence and is satisfied with their independence in accordance with the Listing Rules. The Company considers that all Independent Non-executive Directors meet the independence guidelines set out in Rule 3.13 of the Listing Rules and are independent to the Company.

AUDIT COMMITTEE

The Board has established an audit committee (the "Audit Committee") with the term of references in accordance with the Listing Rules. The Audit Committee currently comprises three Independent Non-executive Directors, namely, Mr. Ong Chi King (Chairman), Mr. Wong Kwai Sang and Mr. Heung Chee Hang, Eric. The Board recognises the importance of good communication with the Shareholders. Information in relation to the Group is disseminated to the Shareholders in a timely manner through a number of formal channels, which include interim and annual reports, announcements and circulars.

The general meetings of the Company are valuable forum for the Board to communicate directly with the shareholders of the Company (the "Shareholders"). The Shareholders are encouraged to attend the general meetings of the Company.

An extraordinary general meeting of the Company was held on 2 July 2015 (the "EGM") to approve the major and connected transactions of the Company. The members of independent board committee attended the EGM to answer the questions from the Shareholders. An annual general meeting of the Company was held on 11 November 2015 (the "2015 AGM"). A notice convening the 2015 AGM contained in a circular of the Company dated 12 October 2015 was dispatched to the Shareholders together with the 2015 Annual Report.

As Mr. Yeung Chi Hang was unable to attend the annual general meeting of the Company held on 11 November 2015 due to business trips. Mr. Wong Po Keung, an Executive Director, was elected and acted as Chairman of the 2015 AGM. He together with the board committees members attended the 2015 AGM to answer the questions from the Shareholders. The Chairman of the 2015 AGM explained detailed procedures for conducting a poll. All the resolutions proposed at the 2015 AGM were passed by the Shareholders by way of poll. The results of the poll were published on the websites of the Stock Exchange, the Singapore Stock Exchange and the Company on 11 November 2015.

SHAREHOLDERS' RIGHTS

The general meetings of the Company provide an opportunity for communication between the Shareholders and the Board. An annual general meeting of the Company shall be held in each year at such place as may be determined by the Board. Each general meeting, other than an annual general meeting, shall be called an extraordinary general meeting ("EGM"). Set out below are procedures by which Shareholders may (a) convene an EGM; (b) put forward enquires to the Board; and (c) put forward proposals at general meetings. The procedures are subject to the Articles of Association and applicable legislation and regulation.

Procedures for Shareholders to convene EGM

Any one or more Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid-up capital of the Company carrying the right of voting at general meetings of the Company, shall at all times have the right, by written requisition to the Board or the Company Secretary, to require an EGM to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two months after the deposit of such requisition.

The written requisition must state the business to be transacted at the meeting, signed by the requisitionist(s) and deposited at the Company's registered office (with a copy of the said written requisition deposited at the Company's Hong Kong office) for the attention of the Board or the Company Secretary, and may consist of several documents in like form, each signed by one or more requisitionists. The requisition will be verified with the Company's branch share registrars in Hong Kong and upon their confirmation that the requisition is proper and in order, the Company Secretary will ask the Board to convene an EGM by serving sufficient notice in accordance with the requirements under the Articles of Association to all the registered Shareholders. On the contrary, if the requisition has been verified as invalid, the requisitionist(s) will be advised of this outcome and accordingly, an EGM will not be convened as requested.

The notice period to be given to all the registered Shareholders for consideration of the proposal raised by the requisitionist(s) concerned at the EGM varies according to the nature of the proposal, as follows:

- Not less than 14 clear days' and not less than 10 clear business days' notice in writing if the proposal constitutes an ordinary resolution of the Company; and
- Not less than 21 clear days' and not less than 10 clear business days' notice in writing if the proposal constitutes a special resolution of the Company.

- Procedures for putting enquiries to the Board

Shareholders may, at any time, direct enquiries to the Board. All enquiries shall be in writing and sent by post to the principal place of business of the Company in Hong Kong or by email to info@greencer.com for the attention of the Board.

Procedures for putting forward proposals at general meetings

To put forward proposals at a general meeting of the Company, a Shareholder should lodge a written request, duly signed by the Shareholder concerned, setting out the proposals at the Company's registered office (with a copy of the said written request lodged at the Company's Hong Kong office) for the attention of the Board and the Company Secretary. The request will be verified with the Company's branch share registrar in Hong Kong and upon its confirmation that the request is proper and in order, the Company Secretary will pass the request to the Board. Whether a proposal will be put to a general meeting will be decided by the Board in its discretion, unless the proposal put forward by a Shareholder is (i) pursuant to a requisition by a Shareholder to convene an EGM referred to above or (ii) forms part of ordinary business to be considered at an annual general meeting as described in Article 75 of the Articles of Association.

1. GENERAL INFORMATION

China Environmental Resources Group Limited (the "Company") is a limited liability company incorporated in the Cayman Islands. The address of its registered office is Ugland House, South Church Street, P.O. Box 309, George Town, Grand Cayman, Cayman Islands, British West Indies. The address of its principal place of business is Room 2811, 28/F, West Tower, Shun Tak Centre 168–200 Connaught Road Central, Hong Kong. The Company's shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") and Singapore Exchange Limited.

The principal activities of the Company and its subsidiaries (collectively known as the "Group") are set out in note 36 to the consolidated financial statements.

2. APPLICATION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS

In the current year, the Group has adopted all the new and revised Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") that are relevant to its operations and effective for its accounting year beginning on 1 July 2015. HKFRSs comprise Hong Kong Financial Reporting Standards, Hong Kong Accounting Standard, and Interpretations. The adoption of these new and revised HKFRSs did not result in significant changes to the Group's accounting policies, presentation of the Group's financial statements and amounts reported for the current year and prior years.

The Group has not applied the new HKFRSs that have been issued but are not yet effective. The Group has already commenced an assessment of the impact of these new HKFRSs but is not yet in a position to state whether these new HKFRSs would have a material impact on its results of operations and financial position.

3. SIGNIFICANT ACCOUNTING POLICIES

Statement of compliance

These financial statements have been prepared in accordance with HKFRSs issued by the HKICPA, accounting principles generally accepted in Hong Kong and the applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and by the Hong Kong Companies Ordinance.

These financial statements have been prepared under the historical cost convention, as modified by the revaluation of biological assets which are carried at their fair values less costs to sell and financial assets at fair value through profit or loss which are carried at their fair values. These financial statements are presented in Hong Kong Dollars ("HK\$") and all values are rounded to the nearest thousand except when otherwise indicated.

The preparation of financial statements in conformity with HKFRSs requires the use of certain key assumptions and estimates. It also requires the directors of the Company to exercise its judgments in the process of applying the accounting policies. The areas involving critical judgments and areas where assumptions and estimates are significant to these financial statements. are disclosed in note 4 to the consolidated financial statements.

The significant accounting policies applied in the preparation of these financial statements are set out below.

Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 30 June. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties, to determine whether it has control. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date the control ceases.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Business combination and goodwill

The acquisition method is used to account for the acquisition of a subsidiary in a business combination. The cost of acquisition is measured at the acquisition-date fair value of the assets given, equity instruments issued, liabilities incurred and contingent consideration. Acquisition-related costs are recognised as expenses in the periods in which the costs are incurred and the services are received. Identifiable assets and liabilities of the subsidiary in the acquisition are measured at their acquisitiondate fair values.

The excess of the cost of acquisition over the Company's share of the net fair value of the subsidiary's identifiable assets and liabilities is recorded as goodwill. Any excess of the Company's share of the net fair value of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss as a gain on bargain purchase which is attributed to the Company.

综合入賬

綜合財務報表包括本公司及其附屬公司截 至六月三十日止之財務報表。附屬公司是 指本集團對其擁有控制權的實體。當本集 團承受或享有參與實體所得的可變回報, 且有能力透過其對實體的權力影響該等回 報時,則本集團控制該實體。當本集團的 現有權力賦予其目前掌控有關業務(即大幅 影響實體回報的業務)時,則本集團對該實 體行使權力。

在評估控制權時,本集團會考慮其潛在投 票權以及其他人士持有的潛在投票權,以 釐定其是否擁有控制權。在持有人能實際 行使潛在投票權的情況下,方會考慮其權 利。

附屬公司在控制權轉移至本集團之日綜合 入賬,而在控制權終止之日起停止綜合入 賬。

集團內公司間之交易、結餘及未變現溢利 均予以對銷。除非交易提供憑證顯示所轉 讓資產出現減值,否則未變現虧損亦予以 對銷。倘有需要,附屬公司之會計政策會 作出調整,以確保符合本集團採納之政策。

業務合併及商譽

Business combination and goodwill (Continued)

Goodwill is tested annually for impairment or more frequently if events or changes in circumstances indicate that it might be impaired. Goodwill is measured at cost less accumulated impairment losses. The method of measuring impairment losses of goodwill is the same as that of other assets as stated in the accounting policy below. Impairment losses of goodwill are recognised in consolidated profit or loss and are not subsequently reversed. Goodwill is allocated to cashgenerating units that are expected to benefit from the synergies of the acquisition for the purpose of impairment testing.

The non-controlling interests in the subsidiary are initially measured at the non-controlling shareholders' proportionate share of the net fair value of the subsidiary's identifiable assets and liabilities at the acquisition date.

Foreign currency translation

- (a) Functional and presentation currency Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional and presentation currency.
- (b) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

The results and financial position of all the Group entities that have a functional currency different from the Company's presentation currency are translated into the Company's presentation currency as follows:

- (i) Assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- (ii) Income and expenses are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case incomes and expenses are translated at the exchange rates on the transaction dates); and
- (iii) All resulting exchange differences are recognised in the foreign currency translation reserve.

On consolidation, exchange differences arising from the translation of the net investment in foreign entities and of borrowings are recognised in the foreign currency translation reserve. When a foreign operation is sold, such exchange differences are recognised in consolidated profit or loss as part of the gain or loss on disposal.

Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less their residual values over the estimated useful lives on a straight-line basis. The principal annual rate is as follows:

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period.

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

Investment properties

Investment properties are land and/or buildings held to earn rentals and/or for capital appreciation. An investment property is measured initially at its cost including all direct costs attributable to the property.

After initial recognition, the investment property is stated at cost less accumulated depreciation and impairment losses. The depreciation is calculated using the straight line method to allocate the cost to the residual value over its estimated useful life of 30.5 years.

The gain or loss on disposal of an investment property is the difference between the net sales proceeds and the carrying amount of the property, and is recognised in profit or loss.

Leases that do not substantially transfer to the Group all the risks and rewards of ownership of assets are accounted for as operating leases. Lease payments (net of any incentives received from the lessor) are recognised as an expense on a straight-line basis over the lease term.

The Group as lessor

(i) Operating leases

Leases that do not substantially transfer to the lessees all the risks and rewards of ownership of assets are accounted for as operating leases. Rental income from operating leases is recognised on a straight-line basis over the term of the relevant lease.

Intangible assets

Intangible assets acquired in a business combination

Intangible assets acquired in a business combination and recognised separately from goodwill are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets acquired in a business combination are measured at cost less accumulated amortisation and accumulated impairment losses (if any), on the same basis as intangible assets that are acquired separately. Amortisation is calculated on a straight-line basis over their estimated useful lives of 30 years.

Research and development expenditure

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

Biological assets

A biological asset is defined as a living plant managed by the Group which is involved in the agricultural activity of the transformation of biological assets for sale, into agricultural produce, or into additional biological assets.

Biological assets comprise standing timbers in the People's Republic of China (the "PRC"), which are stated at fair value less costs to sell at initial recognition and at the end of each reporting period. The gain or loss arising on initial recognition, and subsequent change in fair values less costs to sell of biological assets is recognised in profit or loss in the reporting period in which it arises. Costs to sell are the incremental costs directly attributable to the disposal of an asset, excluding finance costs and taxes, standing timber is transferred to inventory at its fair value less costs to sell at the date of harvest.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out basis. The cost of finished goods and work in progress comprises raw materials, direct labour and an appropriate proportion of all production overhead expenditure, and where appropriate, subcontracting charges. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the statement of financial position when the Group becomes a party to the contractual provisions of the instruments.

Financial assets are derecognised when the contractual rights to receive cash flows from the assets expire; the Group transfers substantially all the risks and rewards of ownership of the assets; or the Group neither transfers nor retains substantially all the risks and rewards of ownership of the assets but has not retained control on the assets. On derecognition of a financial asset, the difference between the asset's carrying amount and the sum of the consideration received and the cumulative gain or loss that had been recognised in other comprehensive income is recognised in the profit or loss.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires. The difference between the carrying amount of the financial liability derecognised and the consideration paid is recognised in profit or loss.

Investments

Investments are recognised and derecognised on a trade date basis where the purchase or sale of an investment is under a contract whose terms require delivery of the investment within the timeframe established by the market concerned, and are initially measured at fair value, plus directly attributable transaction costs except in the case of financial assets at fair value through profit or loss.

Financial assets at fair value through profit or loss are either investments classified as held for trading or designated as at fair value through profit or loss upon initial recognition. These investments are subsequently measured at fair value. Gains or losses arising from changes in fair value of these investments are recognised in profit or loss.

Trade, loans and other receivables

Trade, loans and other receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less allowance for impairment. An allowance for impairment of trade, loans and other receivables is established when there is objective evidence that the Group will not be able to collect all amounts due according to the original terms of receivables. The amount of the allowance is the difference between the receivables' carrying amount and the present value of estimated future cash flows, discounted at the effective interest rate computed at initial recognition. The amount of the allowance is recognised in profit or loss.

Impairment losses are reversed in subsequent periods and recognised in profit or loss when an increase in the receivables' recoverable amount can be related objectively to an event occurring after the impairment was recognised, subject to the restriction that the carrying amount of the receivables at the date the impairment is reversed shall not exceed what the amortised cost would have been had the impairment not been recognised.

Cash and cash equivalents

For the purpose of the statement of cash flows, cash and cash equivalents represent cash at bank and on hand, demand deposits with banks and other financial institutions, and shortterm highly liquid investments which are readily convertible into known amounts of cash and subject to an insignificant risk of change in value. Bank overdrafts which are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents.

Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

Trade and other payables

Trade and other payables are stated initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

Equity instruments

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable and is recognised when it is probable that the economic benefits will flow to the Group and the amount of revenue can be measured reliably.

Revenue from the sales of plantation products, trading of plantation materials and motor vehicles are recognised on transfer of significant risks and rewards of ownership, which generally coincides with the time when the goods are delivered and the title has passed to the customers.

Revenue recognition (Continued)

Green technology advisory fee income is recognised when the service is rendered, provided that the costs involved can be measured reliably.

Interest income from a financial asset is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount.

Dividend income is recognised when the right to receive payment is established.

Rental income is recognised on a straight-line basis over the lease term.

Employee benefits

(a) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(b) Pension obligations

The Group contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Group and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged to profit or loss represents contributions payable by the Group to the funds.

(c) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs and involves the payment of termination benefits.

Share options granted to directors and employees The fair value of services received is determined by reference to the fair value of the share options granted at the grant date and is expensed on a straight-line basis over the vesting period, with a corresponding increase in equity (share-based compensation reserve).

At the end of the reporting period, the Group revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the estimates during the vesting period, if any, is recognised in profit or loss, with a corresponding adjustment to share-based compensation reserve.

At the time when the share options are exercised, the amount previously recognised in share-based compensation reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to accumulated losses.

Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

Impairment of assets

At the end of each reporting period, the Group reviews the carrying amounts of its tangible and intangible assets except biological assets, goodwill, financial assets at fair value through profit or loss, inventories and receivables to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of any impairment loss. Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash generating unit to which the asset belongs.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

If the recoverable amount of an asset or cash-generating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cash-generating unit is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease.

Where an impairment loss subsequently reverses, the carrying amount of the asset or cash-generating unit is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined (net of amortisation or depreciation) had no impairment loss been recognised for the asset or cash-generating unit in prior years. A reversal of an impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the reversal of the impairment loss is treated as a revaluation increase.

Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or nonoccurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

Events after the reporting period

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period or those that indicate the going concern assumption is not appropriate are adjusting events and are reflected in the financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

4. CRITICAL JUDGEMENTS AND KEY ESTIMATES

Key sources of estimation uncertainty

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

(a) Fair values of biological assets

The Group appointed an independent professional valuer to assess the fair values of the biological assets. In determining the fair values, the valuer has utilised a method of valuation which involves certain estimates. The directors have exercised their judgement and are satisfied that the method of valuation is reflective of the current market conditions.

(b) Impairment of intangible assets

The Group assesses whether there are any indicators of impairment for all intangible assets at the end of each reporting period. Such assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an assets or a cash-generating unit exceeds its recoverable amount, which is higher of its fair value less costs to sell and its value in use. To calculate the fair value less costs to sell, the management estimates the expected future cash flows from the asset or cash-generating unit and chooses a suitable discount rate in order to derive the present value of those cash flows.

(c) Property, plant and equipment and depreciation

The Group determines the estimated useful lives, residual values and related depreciation charges for the Group's property, plant and equipment. This estimate is based on the historical experience of the actual useful lives and residual values of property, plant and equipment of similar nature and functions. The Group will revise the depreciation charge where useful lives and residual values are different to those previously estimated, or it will writeoff or write-down technically obsolete or non-strategic assets that have been abandoned or sold.

- (c) 物業、廠房及設備及折舊 本集團就本集團的物業、廠房及設備 釐定估計可使用年期、剩餘價值及相 關的折舊開支。估計乃基於性質及用 途類似的物業、廠房及設備的實際可 使用年期及剩餘價值的歷史經驗。可 使用年期及剩餘價值與原先估計不同 時,本集團將重訂折舊開支,或撇銷 或撇減技術過時或已報廢或出售之非 戰略性資產。

(d) Impairment of goodwill

Determining whether goodwill is impaired requires an estimation of the value in use of the cash-generating unit to which goodwill has been allocated. The value in use calculation requires the Group to estimate the future cash flows expected to arise from the cash-generating unit and a suitable discount rate in order to calculate the present value.

(e) Impairment loss for bad and doubtful debts

The Group makes impairment loss for bad and doubtful debts based on assessments of the recoverability of the trade, loan and other receivables, including the current creditworthiness, collateral security, financial condition and past collection history of each debtor. Impairments arise where events or changes in circumstances indicate that the balances may not be collectible. The identification of bad and doubtful debts requires the use of judgement and estimates. Where the actual result is different from the original estimate, such difference will impact the carrying value of the trade and other receivables and doubtful debt expenses in the year in which such estimate has been changed. If the financial conditions of the debtors were to deteriorate, resulting in an impairment of their ability to make payments, additional allowances may be required.

(f) Income taxes

The Group is subject to income taxes in several jurisdictions. Significant estimates are required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.

(g) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and selling expense. These estimates are based on the current market condition and the historical experience of manufacturing and selling products of similar nature. It could change significantly as a result of changes in customer taste and competitor actions. The Group will reassess the estimates by the end of each reporting period.

5. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: foreign currency risk, price risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Foreign currency risk

The Group has minimal exposure to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in Hong Kong dollars and Renminbi which are the functional currencies of the principal operating entities of the Group. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group will monitor its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

(b) Price risk

The Group's financial assets at fair value through profit or loss are measured at fair value at the end of each reporting period. Therefore, the Group is exposed to equity price risk. The directors manage this exposure by maintaining a portfolio of investments with different risk profiles. The Group's equity price risk is mainly concentrated on equity instruments guoted in the Stock Exchange.

At 30 June 2016, if the share prices of the investments increase/decrease by 10%, profit or loss for the year would have been HK\$454,000 (2015: HK\$3,640,000) higher/ lower, arising as a result of the fair value gain/loss of the investment.

(a) 外幣風險

由於大部分業務交易、資產及負債主 要以本集團主要營運公司的功能貨幣 港元及人民幣計值,故本集團的外匯 風險甚微。本集團現時並無有關外匯 交易、資產及負債的外匯對沖政策。 本集團會密切監控外匯風險,並於有 需要時考慮對沖重大外匯風險。

(b) 價格風險

本集團於損益賬按公允值處理之金融 資產於報告期末按公允值計量,因此 本集團承擔股本價格風險。董事透過 維持不同風險的投資組合來管理風 險。本集團之股本價格風險主要集中 於在聯交所所報之股本工具。

於二零一六年六月三十日,如投資之 股價增加/減少10%,則將因投資 公允值收益/虧損而導致年內損益增 加/減少454,000港元(二零一五年: 3.640.000港元)。

(c) Credit risk

The carrying amount of the bank and cash balances, trade and other receivables, loans receivable and financial assets at fair value through profit or loss included in the statement of financial position represents the Group's maximum exposure to credit risk in relation to the Group's financial assets.

It has policies in place to ensure that sales are made to customers with an appropriate credit history.

The credit risk on bank and cash balances is limited because the counterparties are banks with high creditratings assigned by international credit-rating agencies.

At the end of the reporting period, the Group had certain concentration of credit risk as approximately 39% (2015: Nil) and 99% (2015: Nil) of the Group's trade receivables were due from the Group's largest customer and the five largest customers, respectively.

The credit risk on financial assets at fair value through profit or loss is limited because the counterparty is a wellestablished securities broker firm in Hong Kong.

The Group's maximum exposure to credit risk in the event that counterparties fail to perform their obligations at 30 June 2016 in relation to each class of recognised financial assets is the carrying amounts of those assets as stated in the consolidated statement of financial position. The Group's credit risk is primarily attributable to its trade and other receivables and loans receivable. In order to minimise credit risk, the directors have delegated a team to be responsible for the determination of credit limits, credit approvals and other monitoring procedures. In addition, the directors review the recoverable amount of each individual trade and loan debt regularly to ensure that adequate impairment losses are recognised for irrecoverable debts. In this regard, the directors consider that the Group's credit risk is significantly reduced.

透過損益按公允值計量之金融資產的 信貸風險有限,原因是交易對手為香 港成立已久的證券經紀公司。

The Group's biological assets represent standing timbers on plantation land of approximately 30,000 Chinese Mu with a lease term of 30 years, expiring in 2038. The standing timbers comprise mostly poplar trees (accounting over 99% of the total standing timbers), mixed with a very small portion of other species of deciduous trees such as elm, willow. During the year, the Group did not harvest or sell any standing timbers (2015: Nil).

The Group's standing timbers as at 30 June 2016 were independently valued by Roma Appraisals Limited ("Roma") which comprises a group of independent professional valuers with experience and expertise in relation to biological assets valuation. Their team consists of professional valuers and agricultural experts who work together in a wide array of biological assets to ensure the reliability and fairness of their valuation results. Roma has adopted a market approach for the valuation of standing timbers. The method uses the present market value in terms of price per unit cubic meter of round logs and the total merchantable volume of timbers on the plantation land as at 30 June 2016 as a basis for calculating the fair value less costs to sell of the biological assets. Roma has adopted the measured merchantable volume of standing timbers as indicated by the forest manager of the Group and also verified the market price per cubic meter of logs by referencing to the market price lists, after taking into account of local timber manufacturing factories as well. The principal assumptions adopted are as follows:

- 1. no material changes in the existing political, legal, technological, fiscal, economic conditions, climate and any other natural condition;
- 2. poplar trees can grow to certain size and can be legally cut in 8 years and in 5 years with organic fertilisers added; and
- 3. the movements of the price of the timber, the setup fee and maintenance fee for tree plantation will move in line with the price index of forestry product in China.

The valuation techniques used in the determination of fair values as well as the key inputs used in the valuation models are disclosed in note 6 to the consolidated financial statements.

Nature risk

The Group's revenue depends significantly on the ability to harvest wood at adequate levels. The ability to harvest on the plantation land and the growth of the trees on the plantation land may be affected by unfavorable local weather conditions and natural disasters. Weather conditions such as earthquakes, rainfall, underground water, fire, disease, insect infestation and pests are examples of such events. The occurrence of severe weather conditions or natural disasters may diminish the supply of trees available for harvesting on the plantation land, or otherwise impede the Group's logging operations or the growth of the trees on the plantation land, which in turn may have a material adverse effect on the Group's ability to produce the products in sufficient quantities and a timely manner.

The Group entered into a sale and purchase agreement and a supplemental agreement on 27 November 2013 and 16 December 2013, respectively, with an independent third party in relation to the acquisition of 100% equity interest of a target company and its subsidiaries which are mainly engaged in hotel operations in the PRC (the "Proposed Acquisition"). On 23 December 2013, an amount of HK\$150,000,000 was paid by the Group as refundable deposit.
