The Board wishes to inform the Shareholders and potential investors that based on the review of the information currently available to the Company, the Group is expected to record a profit for the year ending 31 December 2013 as compared with the loss recorded by the Group for the year ended 31 December 2012.

The information contained in this announcement is only a preliminary assessment by the management of the Company based on the currently available information and such information has not been audited or reviewed by the Company's auditor.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by World Wide Touch Technology (Holdings) Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) of Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong) (the “**SFO**”).

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on (i) the preliminary review of the Group's unaudited management accounts for the eight months ended 31 August 2013; (ii) the current business outlook of the Group; and (iii) the disposal of shares in Fingerprint Cards AB and DDS, Inc. by the Group, details of which have been disclosed by the Company in its announcements dated 21 May 2013, 11 October 2013 and 15 October 2013, respectively, the Group is expected to record a profit for the year ending 31 December 2013 as compared with the loss recorded by the Group for the year ended 31 December 2012, mainly attributable to the recognition of the gain from the disposals of shares in Fingerprint Cards AB and DDS, Inc. by the Group.
