There was no share entitling the holders to attend and abstain from voting in favour of the above resolutions at the Annual General Meeting as set out in Rule 13.40 of the Listing Rule. No Shareholder was required under the Listing Rules to abstain from voting on any of the resolutions at the Annual General Meeting. No Shareholder has stated his/her intention in the Circular to vote against or to abstain from voting on any of the above resolutions.

The Company’s Hong Kong branch share registrar, Tricor Investor Services Limited, was appointed as the scrutineer at the Annual General Meeting for the vote-taking.
