CHANGE OF FINANCIAL YEAR END DATE

Reasons for the Change

The Board considers that the change of financial year end date to 30 June will enable the Group to rationalize and more efficiently use its resources for the preparation of its results announcements as well as interim and annual reports, given the Change will allow the Company to:

- (i) avoid competition of resources with other listed companies with regard to results announcement and interim/annual report-related external services under the peak reporting season in the market as the majority of the companies listed on The Stock Exchange of Hong Kong Limited have a 31 December financial year end;
- (ii) better planning of its audit schedule with its auditors during non-peak reporting periods, in addition to taking into account the Christmas and New Year holidays from the end of December to the beginning of January of each calendar year, which reduces the pressure on the Company's workflow around 31 December of each year and thereby promotes cost savings and efficiencies; and
- (iii) remove the uncertainty from the variation in the dates of the Chinese New Year Holiday which put pressure on the workflow.

To the best of its knowledge, belief and understanding, the Board does not foresee any material adverse impact on the Group resulting from the Change nor is there any other significant matter that needs to be brought to the attention of the shareholders of the Company relating to the Change.
