**VOLUNTARY ANNOUNCEMENT**

**CCNG and Beijing Zhonghong Lan Hai Signed Strategic Cooperation Agreement**

This announcement is a voluntary disclosure made by China Carbon Neutral Development Group Company Limited ("CCNG" or the "Company", collectively with its subsidiaries, the "Group") to inform the Company's shareholders and interested investors of the latest developments regarding the Group's business.

The Board of Directors of the Company is pleased to announce that the Group has officially signed a Strategic Cooperation Agreement (the "Agreement") with Beijing Zhonghong Lanhai Animal Husbandry Technology Development Company Limited\* (北京中宏藍海牧業科技發展有限公司) ("Beijing Zhonghong Lanhai"). Both parties will deepen cooperation in the fields of carbon peaking, carbon neutrality, and new energy industries, with a total planned investment of approximately RMB 10 billion. By leveraging their respective strengths and adhering to the principles of "joint development and sincere cooperation", the parties will collaborate on the following projects:

According to the Agreement, both parties will accelerate the implementation of various projects such as jointly establish a dedicated working team to promote the "Digital Control and Demonstration Platform for Dual-Carbon" project, providing full-process digital management services for carbon emissions and energy consumption data for local governments, industrial parks, and enterprises, including areas such as carbon resource development, assessment, trading, and planning; In addition, they will jointly promote the "New Energy Vehicle Charging Pile and Photovoltaic Storage Charging Integration" project, collaboratively build public charging infrastructure and intelligent charging network platforms for new energy vehicles, achieving integrated monitoring, payment settlement, and operational management of charging data, and constructing a comprehensive new energy charging network covering urban areas and surrounding regions. Besides, they will jointly advance the "Green New Energy Transportation System Construction" project by promoting the replacement of traditional vehicles with new energy vehicles, centralized procurement, and autonomous operation to accelerate the electrification transformation in public transportation, passenger transport, logistics, and other fields, thereby speeding up the adoption of new energy transport in targeted regions. Additionally, they will jointly promote the "New Energy Battery Recycling and Second-Life Utilization" project by establishing an intelligent power battery recycling system, improving lithium battery disassembly efficiency and resource utilization, and promoting the green transformation of the retired battery industry chain.

**Background of the Partner**

Beijing Zhonghong Lanhai Animal Husbandry Technology Development Company Limited\* (北京中宏藍海牧業科技發展有限公司) is a mixed-ownership reform company under China Huaneng Group\* (華能集團). The company is based in Beijing and Wuhan, and it is aiming for nationwide development. It is a diversified enterprise primarily focused on new energy business. The company engages in energy project development and construction, as well as comprehensive consulting services in the dual-carbon industry. It possesses extensive market resources and strong investment demand.

The Board believes that the strategic cooperation agreement signed with Beijing Zhonghong Lanhai will facilitate the Group's expansion into markets related to carbon peaking, carbon neutrality, and new energy industries.
