THE ISSUE OF ULTRA SHORT-TERM COMMERCIAL PAPER IN THE PRC BY WUHAN ZHENG TONG UNITED INDUSTRIAL INVESTMENT GROUP CO., LTD., A WHOLLY-OWNED SUBSIDIARY OF THE COMPANY

The Board of directors of China ZhengTong Auto Services Holdings Limited (the “Company”) (the “Board”) is pleased to announce that Wuhan ZhengTong United Industrial Investment Group Co., Ltd. (the “Issuer”), a wholly-owned subsidiary of the Company, has completed the issue of the third tranche of ultra short-term commercial paper for the year 2017 (the “Ultra Short-term Commercial Paper”) in the PRC on 14 August 2017. The aggregate principal amount of the Ultra Short-term Commercial Paper is RMB300 million, at the interest rate of 6.39% per annum, and with a term of 270 days. Both the par value and the issuing price of the Ultra Short-term Commercial Paper are RMB100 per unit.

The net proceeds from the issue of the Ultra Short-term Commercial Paper are intended to be used for repayment of bank loans.

In accordance with the relevant laws and regulations in the PRC, relevant documents in relation to the Issuer and the Ultra Short-term Commercial Paper are also published on the websites of Shanghai Clearing House (www.shclearing.com) and China Foreign Exchange Trade System (www.chinamoney.com.cn).
