UNAUDITED OPERATING STATISTICS FOR MAY 2014

The board of directors (the “Board”) of KWG Property Holding Limited (the “Company”) is pleased to announce certain unaudited operating statistics of the Company and its subsidiaries (the “Group”) for May 2014 as follows.

In May 2014, the Group’s gross pre-sales value amounted to RMB2,037 million. The Group’s attributable pre-sales value amounted to RMB1,360 million (as compared to RMB2,044 million in April 2014 and RMB1,519 million in May 2013), representing a month-on-month decrease of 33.5% and a year-on-year decrease of 10.5%, respectively. The Group’s attributable pre-sales area amounted to approximately 99,000 sq. m..

For the first five months, the Group has achieved a total of RMB8,214 million of attributable pre-sales value, representing 39.1% of the Group’s full year pre-sales target of RMB21 billion.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
