MONTHLY UPDATE

**OPERATING INFORMATION FOR THE ELEVEN MONTHS
ENDED 30 NOVEMBER 2014**

The Group recorded an accumulated new contract value of HK\$59.52 billion in the eleven months ended 30 November 2014, representing a Year-on-Year (“YoY”) growth of 32.4%, and hence achieved a 99.2% completion of the full year target of 2014 (which has been revised up to no less than HK\$60.00 billion).

As of 30 November 2014, the on-hand contract value of the Company amounted to approximately HK\$163.52 billion, among which the backlog was approximately HK\$99.63 billion (representing a YoY growth of 28.6%), which meets the Group’s expected works in the next three years.

Major New Contracts Awarded in November 2014 include:

Affordable Housing Build-Transfer Project in Huangyan District of Taizhou, Zhejiang Province (the client of such project is Taizhou Municipal Government and the attributable contract value of the Group is about HK\$7.5 billion);
