**OPERATING INFORMATION FOR THE TWELVE MONTHS  
ENDED 31 DECEMBER 2016**

The Group recorded an accumulated new contract value of HK\$83.77 billion in the twelve months ended 31 December 2016, and hence successfully achieved the full year target of 2016 (which has been revised up to no less than HK\$83.0 billion).

As of 31 December 2016, the on-hand contract value of the Group amounted to approximately HK\$249.63 billion, among which the backlog was approximately HK\$153.88 billion.

**Major New Contracts Awarded in December 2016 include:**

The Dadong First-class Highway Project with Public-Private-Partnership (PPP), Liupanshui, Guizhou Province (The attributable contract value of the Group is about HK\$2.86 billion. Such project includes the construction of the first phase project of the Dadong first-class highway with 24 kilometers (including a suspension bridge of 1,250 meters) and the bypass link of Dadong highway with 21 kilometers. The construction period is about 36 months.).

**New Contracts Targets for 2017:**

The Group is pleased to announce that the Group's target for new contracts to be awarded in 2017 is no less than HK\$90.00 billion.
