ORDINARY RESOLUTIONS

- 1. To receive and consider the audited consolidated financial statements for the year ended 31 December 2021 together with the Report of the directors of the Company (the "Directors") and Independent Auditor's Report.
- 2. To declare a final dividend of RMB12 cents per ordinary share for the year ended 31 December 2021 (payable in cash in Hong Kong dollars with an option for scrip dividend).
