**1. INTRODUCTION**

The purpose of this circular is to provide you with notice of the AGM and the relevant information regarding the resolutions to be proposed at the AGM relating to:

- (a) the granting of the Issue Mandate to the Directors;
- (b) the granting of the Repurchase Mandate to the Directors;

- (c) the granting of the extension mandate to extend the Issue Mandate by the addition of an amount representing the number of the Shares purchased or repurchased by the Company pursuant to the Repurchase Mandate;
- (d) the re-election of the retiring Directors; and
- (e) the re-appointment of the auditor of the Company.

### 2. THE ISSUE MANDATE

The Directors have been granted a general unconditional mandate to allot, issue and deal with the Shares pursuant to the ordinary resolution of the Shareholders passed in the previous annual general meeting held on 23 May 2024 (the “**Previous AGM**”). On 15 May 2025, the Company signed a subscription agreement with Lofty Islet Holding Limited, a company incorporated in the British Virgin Islands with limited liability, for subscription (the “**Subscription**”) of 5,400,000 Shares under general mandate. Upon completion of the Subscription, 100% of the general mandate will be utilised (after adjustment for the effect of the Share Consolidation). For further details on the Subscription, please refer to the announcement of the Company dated 15 May 2025.

As the general mandate granted under the previous AGM will be fully utilised upon the completion of the Subscription, an ordinary resolution will be proposed at the AGM that the Directors be granted a general unconditional mandate to exercise all powers of the Company to allot, issue and deal with the Shares not exceeding the aggregate of 20% of the number of the issued Shares as at the date of the passing of the relevant resolution. As at the Latest Practicable Date, the total number of issued Shares was 27,000,000 and the Company held no Treasury Shares.

Subject to passing of the resolution proposed, assuming that the Subscription is completed and there would be no other changes in the number of issued Shares after the Latest Practicable Date and prior to the AGM, the maximum number of new Shares which can be issued under the Issue Mandate will be 6,480,000 Shares, representing 20% of the expected number of Shares in issue as at the date of the AGM.

Details of the Issue Mandate are set out in the ordinary resolution as referred to in resolution no. 4 of the notice of the AGM.

### 3. THE REPURCHASE MANDATE

The Directors have been granted a general unconditional mandate to exercise all powers of the Company to purchase or repurchase Shares pursuant to the ordinary resolution of the Shareholders passed in the Previous AGM. As at the Latest Practicable Date, such repurchase mandate has not been utilized and will lapse at the conclusion of the AGM. Therefore, an ordinary resolution will be proposed at the AGM that the Directors be granted a general unconditional mandate to exercise all powers of the Company to purchase or repurchase the Shares not exceeding the aggregate of 10% of the number of the issued

Shares as at the date of the passing of the relevant resolution. As at the Latest Practicable Date, the total number of issued Shares was 27,000,000 and the Company held no Treasury Shares.

Subject to passing of the resolution proposed, assuming that the Subscription is completed and there would be no other changes in the number of issued Shares after the Latest Practicable Date and prior to the AGM, the maximum number of Shares which the Company can purchase or repurchase would be 3,240,000, representing 10% of the expected number of Shares in issue as at the date of the AGM.

An explanatory statement giving the particulars required under the Listing Rules in respect of the Repurchase Mandate to provide the Shareholders with all the information reasonably necessary to enable them to make an informed decision whether to vote for or against the resolution is set out in the Appendix I to this circular.

Details of the Repurchase Mandate are set out in the ordinary resolution as referred to in resolution no. 5 of the notice of the AGM.

The Issue Mandate and Repurchase Mandate will remain in effect until whichever is the earliest of (i) the conclusion of the next annual general meeting of the Company; or (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles or any applicable laws to be held; or (iii) the passing of an ordinary resolution of the Shareholders in general meeting revoking or varying such mandate.

#### **4. EXTENSION OF ISSUE MANDATE**

In addition, if the Issue Mandate and the Repurchase Mandate are granted, an ordinary resolution will be proposed at the AGM to extend the Issue Mandate by the addition to the number of the Shares which may be issued, allotted and dealt with or agreed conditionally or unconditionally to be issued, allotted and dealt with by the Directors pursuant to the Issue Mandate of an amount representing the number of the issued Shares purchased or repurchased by the Company pursuant to the Repurchase Mandate.

Details of the extension of the Issue Mandate are set out in the ordinary resolution as referred to in resolution no. 6 of the notice of the AGM.

#### **5. RE-ELECTION OF THE DIRECTORS**

Pursuant to Article 108 of the Articles, at each annual general meeting of the Company, one-third of the Directors for the time being or, if their number is not three or a multiple of three, the number nearest to but not less than one-third shall retire from office by rotation provided that every Director shall be subject to retirement at least once every three years.

Pursuant to Article 108 of the Articles, the Directors to retire by rotation shall include (so far as necessary to obtain the number required) any Director who wishes to retire and not to offer himself for re-election. Any Director who has not been subject to retirement by

rotation in the three years preceding the annual general meeting shall retire by rotation at such annual general meeting. Any further Directors so to retire shall be those who have been longest in office since their last re-election or appointment and so that as between persons who became or were last re-elected Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot.

Pursuant to Article 112 of the Articles, any Director appointed by the Board to fill a causal vacancy shall hold office only until the first general meeting of the Company after his appointment and be subject to re-election at such meeting. Any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election. Any Director appointed under the Articles shall not be taken into account in determining the Directors or the number of Directors who are to retire by rotation at an annual general meeting.

In accordance with the above provisions of Article 108 of the Articles, the following Directors, namely, Mr. Chu King Tien (“**Mr. Chu**”) and Mr. Chu Ho Wa (“**Mr. Wilton Chu**”), will retire from office by rotation and, being eligible, offer themselves for re-election as the Directors at the AGM respectively. Pursuant to Article 112 of the Articles of Association, any Director appointed by the Board as an addition to the existing Board shall hold office only until the first annual general meeting of the Company after his appointment and shall then be eligible for re-election at that annual general meeting. Accordingly, Ms. Tang Sze Ning Erica (“**Ms. Tang**”) will hold office as Director only until the conclusion of the AGM and, being eligible, offers herself for re-election. Details in relation to re-election of Directors are set out in the ordinary resolutions as referred to in resolution no. 3 of the notice of the AGM. Biographical details of the retiring Directors proposed to be re-elected at the AGM are set out in Appendix II to this circular.

### 6. RECOMMENDATION OF THE NOMINATION COMMITTEE

On 21 March 2025, the nomination committee of the Board (the “**Nomination Committee**”), having reviewed the composition of the Board, nominated Mr. Chu and Mr. Wilton Chu to the Board for it to recommend to Shareholders for re-election at the Annual General Meeting. Mr. Chu, who is a member of the Nomination Committee, abstained from voting at the Nomination Committee meeting when his nomination was being considered.

The nominations for re-election were made in accordance with the nomination policy and the objective criteria (including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service), with due regard for the benefits of diversity, as set out under the board diversity policy of the Company, details of which are set out in the 2024 annual report of the Company. The Nomination Committee had also taken into account of the respective contributions of Mr. Chu, Mr. Wilton Chu and Ms. Tang to the Board and their commitment to their roles. The Nomination Committee was satisfied with the independence of Ms. Tang, having regard to the independence criteria as set out in Rule 3.13 of the Listing Rules, of which Ms. Tang had confirmed to the Company.

Ms. Tang, who is proposed to be re-elected as an independent non-executive Director of the Company, did not, as at the Latest Practicable Date, hold seven or more directorship in any listed companies. Ms. Tang has been the independent non-executive Director of the Company since 1 April 2025. The Board considers Ms. Tang, who has over 20 years of experience in the corporate finance and accounting fields specialising in corporate finance advisory, capital market transaction advisory and auditing and is a member of Hong Kong Institute of Certified Public Accountants and a member of the Association of Chartered Certified Accountants and a licensed person registered under the SFO as a sponsor principal to conduct Type 6 (advising on corporate finance) regulated activities, will contribute to the diversity of the Board and bring insights in terms of financial and accounting perspectives to the Board. The biographical background of Ms. Tang is more particularly set out in Appendix II of this circular.

The Board accepted Nomination Committee's nominations and recommended Mr. Chu, Mr. Wilton Chu and Ms. Tang to stand for re-election by Shareholders at the AGM. The Board considers that the re-election of Mr. Chu, Mr. Wilton Chu and Ms. Tang as Directors is in the best interest of the Company and Shareholders as a whole. Mr. Chu, Mr. Wilton Chu and Ms. Tang abstained from the discussion and voting at the Board meeting regarding their respective nominations.

Further information about the Board's composition and diversity (including their gender, age, expertise, skills and qualifications) and Directors' attendance record at the Board or committee meetings held by Directors are disclosed in the corporate governance report of the 2024 annual report of the Company.

### **7. RE-APPOINTMENT OF THE AUDITOR**

PKF Hong Kong Limited will retire as the auditor of the Company at the AGM and, being eligible, offer themselves for re-appointment as the auditor of the Company.

Details in relation to re-appointment of auditor of the Company are set out in ordinary resolution as referred to resolution no. 2 of the notice to the AGM.

### **8. CLOSURE OF REGISTER**

The Register will be closed from Thursday, 19 June 2025 to Tuesday, 24 June 2025 (both dates inclusive), the period during which no transfer of the Shares will be effected. In order to be entitled to attend and vote at the AGM, all completed share transfer instruments accompanied by the relevant share certificates shall be lodged with the Share Registrar for registration no later than 4:30 p.m. on Wednesday, 18 June 2025.

### **9. AGM AND PROXY ARRANGEMENT**

The notice convening the AGM to be held at Salon room I, Hyatt Regency Hong Kong, Sha Tin, 18 Chak Cheung Street, Sha Tin, Hong Kong on Tuesday, 24 June 2025 at 3:00 p.m. is set out on pages 16 to 20 of this circular. Ordinary resolutions will be proposed at the AGM for the purpose of considering and if thought fit, approving, among other things, the resolutions set out in the notice of the AGM.

### 10. VOTING AT THE AGM

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of the Shareholders at a general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. Accordingly, the resolutions to be considered and, if thought fit, approved at the AGM will be voted by way of a poll by the Shareholders. An announcement on the poll results will be made by the Company after the AGM, in the manner prescribed under Rule 13.39(5) of the Listing Rules, on the results of the AGM.

### 11. RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

### 12. RECOMMENDATION

The Directors believe that the proposed resolutions as set out in the notice of the AGM, including, among other things, the proposed resolutions in relation to the Issue Mandate, the Repurchase Mandate, the extension of the Issue Mandate, the re-election of retiring Directors and the re-appointment of the auditor of the Company are in the best interest of the Company and the Shareholders as a whole. Accordingly, the Directors recommend all the Shareholders to vote in favour of all the resolutions to be proposed at the AGM.

This appendix serves as an explanatory statement, as required pursuant to Rule 10.06(1)(b) and other relevant provisions of the Listing Rules, to provide you with the requisite information reasonably necessary to enable you to make an informed decision on whether to vote for or against the resolution to approve the grant of the Repurchase Mandate.

## **1. SHARE CAPITAL**

As at the Latest Practicable Date, a total of 27,000,000 Shares were in issue. As at the Latest Practicable Date, the Company did not have any outstanding options, warrants and convertible securities to subscribe for the Shares. As at the Latest Practicable Date, the Company did not hold any Treasury Shares.

Assuming that the Subscription is completed and there are no other changes to the number of issued shares during the period from the Latest Practicable Date until the AGM, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 3,240,000 Shares, representing not more than 10% of the issued share capital of the Company as at the Latest Practicable Date.

## **2. REASONS FOR REPURCHASE**

The Directors have no present intention to repurchase any Shares but consider that the Repurchase Mandate will provide the Company with the flexibility to make such repurchase when appropriate and beneficial to the Company. Such repurchases, depending on market conditions and funding arrangements at the time, may lead to enhancement of the net asset value of the Company and/or the earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders as a whole. The number of the Shares to be repurchased on any occasion and the price and other terms on which the same are repurchased will be decided by the Directors at the relevant time, having regard to the circumstances then pertaining.

## **3. SOURCE OF FUNDS FOR REPURCHASE**

The Company is empowered by the Articles to repurchase its Shares. In repurchasing the Shares, the Company may only apply funds legally available for such purpose in accordance with the Listing Rules, the Memorandum, the Articles, the applicable laws of Cayman Islands and all other applicable laws, rules and regulations, as the case may be.

The Company may not repurchase its own Shares on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange in effect from time to time.

Subject to the foregoing, any repurchase of the Shares by the Company may be made out of profits of the Company, out of share premium, or out of the proceeds of a fresh issue of the Shares made for the purpose of the repurchase or, subject to the Companies Act, out of capital. Any amount of premium payable on the purchase over the par value of the

Shares to be repurchased must be out of profits of the Company, out of the Company's share premium account before or at the time the Shares are repurchased, or subject to the Company Law, out of capital.

As compared with the position disclosed in the audited consolidated financial statements of the Group as at 31 December 2024, the Directors consider that there could be a material adverse impact on the working capital and on the gearing level of the Company in the event that the proposed repurchases under the Repurchase Mandate were to be carried out in full during the proposed purchases period. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or its gearing level which, in the opinion of the Directors, are from time to time appropriate for a Company.

#### **4. NO UNUSUAL FEATURES**

So far as the same may be applicable, the Directors will exercise the power of the Company to make repurchases pursuant to the proposed resolution for the Repurchase Mandate in accordance with the Listing Rules, the Articles and the applicable laws of the Cayman Islands.

Neither this explanatory statement nor the proposed repurchase of Shares pursuant to the Repurchase Mandate has any unusual features.

#### **5. INTENTION TO SELL SHARES**

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their close associates (as defined in the Listing Rules) has any present intention, in the event that the proposed resolution for the Repurchase Mandate is approved by the Shareholders, to sell any of their Shares to the Company pursuant to the Repurchase Mandate.

No core connected person (as defined in the Listing Rules) of the Company has notified the Company that he/she/it has a present intention to sell their Shares to the Company or has undertaken not to sell any of their Shares to the Company, in the event that the Company is authorised to make repurchases of the Shares.

#### **6. CONSEQUENCES UNDER THE TAKEOVERS CODE**

If, as a result of a repurchase of the Shares by the Company pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a Shareholder, or group of Shareholders acting in concert (within the meaning under the Takeovers Code) could obtain or consolidate control of the Company and thereby become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code. Save as aforesaid, the Directors are not aware of any such consequence which may arise under the Takeovers Code if the Repurchase Mandate is exercised.

**APPENDIX I      EXPLANATORY STATEMENT OF THE REPURCHASE MANDATE**

As at the Latest Practicable Date, to the best of the knowledge of the Directors, Golden Villa Ltd. held in total 13,657,500 Shares, representing 50.6% of the issued share capital of the Company. Golden Villa Ltd. is wholly-owned by Mr. Chu. By virtue of the SFO, Mr. Chu is deemed to be interested in the same number of Shares held by Golden Villa Ltd.. If the Repurchase Mandate is exercised in full, assuming that the number of issued Shares is reduced from 27,000,000 shares to 24,300,000 Shares, the shareholding held by Golden Villa Ltd. would have increased to approximately 56.2% of the issued share capital of the Company.

The Directors will not exercise the Repurchase Mandate if the repurchase would result in the number of the Shares which are in the hands of the public falling below 25% of the total number of the Shares in issue (or such other percentage as may be prescribed as the minimum public shareholding under the Listing Rules).

### Executive Directors

**Mr. Chu King Tien**, aged 70, an executive Director and chairman of the Group, was appointed as a Director on 7 June 2012, the date of incorporation of the Company, and has been serving as the executive Director and chairman of the Company since 1 April 2013. He is responsible for the overall corporate development and strategic planning of the Group. Mr. Chu has extensive experience in the disposable battery industry and has been engaged in such business for over 48 years.

In January 1983, Mr. Chu became a director of Golden Power Industries Limited (“**Golden Power Industries**”), an indirect wholly-owned subsidiary of the Company, and has been holding the position since then. From May 1993 to April 2000, Mr. Chu had been the executive director of China Oil and Gas Group Limited, the holding company of Golden Power Industries at the time, which was listed on the Stock Exchange, and was mainly responsible for assisting in corporate planning, marketing and overall administration. In July 2003, Mr. Chu, together with an independent third party, acquired Golden Power Investments (B.V.I.) Limited and its subsidiaries through Golden Villa.

Mr. Chu and Golden Villa, which is wholly-owned by Mr. Chu, are the controlling shareholders (as defined under the Listing Rules) of the Company. Mr. Chu also serves as a director of all the subsidiaries of the Group. Mr. Chu is the father of Mr. Wilton Chu, an executive Director of the Company.

**Mr. Chu Ho Wa**, aged 40, an executive Director, has been serving as an executive Director since 1 April 2013 and is responsible for the overall corporate development and strategic planning of the Group. Mr. Wilton Chu is currently the director of a subsidiary of the Company, namely Merchant Port Limited. Mr. Wilton Chu is also responsible for overseeing the environmental, social and governance (ESG) aspect of the Group, as he is the chairman of the ESG Committee of the Group.

Mr. Wilton Chu acquired the bachelor of science degrees in Mathematics and Chemistry from the Imperial College of Science, Technology and Medicine of the University of London in the United Kingdom in 2006 and 2009, respectively. Mr. Wilton Chu joined the Group in 2009 as an assistant to director in Golden Power Corporation and had been its senior marketing executive from 2011 to 2014 and a manager of its corporate business development department since 2013.

Mr. Wilton Chu is the son of Mr. Chu.



**Independent Non-Executive Directors**

**Ms. Tang Sze Ning Erica**, aged 45, who was appointed as the independent non-executive Director on 1 April 2025, has over 20 years of experience in the corporate finance and accounting fields specialising in corporate finance advisory, capital market transaction advisory and auditing. She is a member of Hong Kong Institute of Certified Public Accountants and a member of the Association of Chartered Certified Accountants. She also a licensed person registered under the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) as a sponsor principal to conduct Type 6 (advising on corporate finance) regulated activities.

She was a senior auditor in Deloitte Touche Tohmatsu from January 2004 to February 2008, and a senior associate in PriceWaterhouseCoopers from July 2008 to April 2009. Ms. Tang acted as the financial controller and the company secretary of Genvon Group Limited (currently known as Beijing Health (Holdings) Limited) (stock code: 2389), the shares of which are listed on the Stock Exchange, from June 2009 to October 2010. Ms. Tang joined SinoPac Securities (Asia) Limited as senior manager from January 2011 to July 2012 focusing on initial public offering (“**IPO**”) projects. She later worked at RaffAello Capital Limited from July 2012 to November 2018 as a director and sponsor principal focusing on IPO projects, acting as compliance adviser and handling numerous corporate finance transactions. She joined Kingsman HK Capital Limited from November 2018 to April 2022 as a director and sponsor principal leading and supervising IPO transactions, acting as compliance adviser and advising on corporate finance. She later joined China Industrial Securities International Capital Limited from September 2022 to October 2024 as a director and sponsor principal also focusing on running IPO transactions and advising on corporate finance. Ms. Tang obtained her bachelor degree in Commerce from the University of New South Wales, Australia in 2003.
