	rks (if any):  Pursuant to the extraordinary general meeting of the Company held on 4 November 2020, a resolution was passed by shareholders of the Company to grant a specific mandate to the directors to allot and issue at par cumulative perpetual non-voting and non-convertible offshore preference shares of HKD100 par value each for the aggregate subscription price of HK\$1,631,620,000 (the "EGM Resolution"). On 22 December 2020, the Company issued 11,000,000 preference shares of HKD100 each and on 31 December 2020, the Company issued 4,705,200 preference shares of HKD100 each, pursuant to the EGM Resolution.	-
