This announcement is made by Wisdom Education International Holdings Company Limited (the “**Company**”) on a voluntary basis. Reference is made to the Company’s announcement dated 13 August 2018 in relation to the acquisition of ordinary shares of the Company (the “**Shares**”) on the market by Ms. Li Suwen (“**Ms. Li**”), the chief executive officer, an executive director and a controlling shareholder of the Company, on 13 August 2018.

The board of directors (the “**Board**”) of the Company hereby announces that as informed by Ms. Li, she has further acquired an aggregate of 500,000 Shares on the market on 14 August 2018 at an average purchase price of approximately HK\$4.7 per Share.

Following the above acquisition of Shares by Ms. Li, Ms. Li’s shareholding interest in the Company has increased to approximately 27.9% of the total issued share capital of the Company as at the date of this announcement. Ms. Li, together with Mr. Liu Xuebin, another controlling shareholder of the Company acting in concert with Ms. Li, are in aggregate interested in 1,501,000,000 Shares, representing approximately 73.5% of the total issued share capital of the Company as at the date of this announcement.

The Board also announces that as informed by Mr. Ng Cheuk Him, the chief financial officer and the company secretary of the Company, he acquired an aggregate of 480,000 Shares on the market on 13 August 2018 and 14 August 2018 at an average purchase price of approximately HK\$4.88 per Share.
