As disclosed in the announcement issued by the Company on 9 May 2019 and 17 June 2019, Ningbo Meishan Bonded Area Yingxiang Investment Centre (Limited Partnership) and the Company entered into the First Domestic Share Subscription Agreement, pursuant to which, Ningbo Meishan Bonded Area Yingxiang Investment Centre (Limited Partnership) has agreed to subscribe for, and the Company has agreed to issue and allot, 12,580,645 Domestic Shares of the Company at the subscription price of RMB6.2 (equivalent to approximately HK\$7.19) per Domestic Share. Shares will be issued after obtaining the approval from the shareholders at the extraordinary general meeting scheduled on 26 July 2019 (“EGM”) of the Company and that all conditional precedents set out in the said agreement have been fulfilled.

Reference is made to the announcements of the Company dated 22 May 2019 and 28 May 2019 in relation to the subscription of a total of 7,300,000 Domestic Shares by seven subscribers pursuant to the Second Domestic Share Subscription Agreements (after execution of the Termination Agreements) at the subscription price of RMB6.2 (equivalent to approximately HK\$7.19) per Domestic Share. Shares will be issued after that all conditional precedents set out in the Second Domestic Share Subscription Agreements have been fulfilled.

A total of 19,880,645 Domestic Shares will be issued once the transactions afore-said transactions have been approved in the EGM.
