The Board wishes to inform the shareholders of the Company and investors that the Group's unaudited net profit for the nine months ended 30 September 2007 are expected to increase substantially compared with the net profit for the same period in 2006 due to the increase in the sales of network servers.

The board of directors (the “**Board**”) of Powerleader Science & Technology Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) wishes to inform the shareholders of the Company and investors that the Group's unaudited net profit for the nine months ended 30 September 2007 are expected to increase substantially compared with the net profit for the same period in 2006.

The expected increase in net profit is mainly due to the increase in the sales of network servers in 2007.
